#### 1. Purpose of Report

1.1 To seek confirmation of Tree Preservation Order No. 02 of 2018 served on 23<sup>rd</sup> May 2018.

# (4) Guidance

The reason given for making this Order was because 'it is considered pruning of the tree by perceived common law right will cause extensive irreparable damage be noticeable and detrimental to the amenity of the area; accordingly it would be expedient to make the tree subject to a TPO in the interests of protecting amenity it affords to the area.'

A site visit was carried out by our previous Tree Maintenance Officer, Julian Turpin and on his assessment a Tree Preservation Order was issued and served.

- 5.2 The Tree Preservation Order includes T1 Oak (Quercus robur) Mature
- 5.3 Objections were received from residents from 3 no. addresses.
- 5.4 It is the considered the opinion of Julian Turpin the previous Tree Management Officer Slough Planning Department, that it is the responsibility of the Local Planning Authority to consider all requests for new Tree Preservation Orders with reference to the relevant guidelines. Please see below outcome of tree evaluation:
  - 5.5.1 Condition & suitability for TPO is good (Highly Suitable)

5.5.2 Retention span (in years) & suitability for TPO – 100+ Years (Highly suitable)

5.5.3 Relative public visibility & suitability for TPO - Medium trees, or larger trees with limited view only (Suitable)

### 6. <u>Conclusion</u>

In light of the above it is being recommended that Tree Preservation Order No. 2 of 2018 be Confirmed.
