<b>Date decision taken</b>	<i>Not yet made – shared with Cabinet 15.03.2021 for information only</i>
<b>Decision maker</b>	Chief Executive (Returning Officer)
<b>Portfolio</b>	N/A (non-executive decision)
<b>Details of decision taken</b>	<p>That the Borough’s scheme of polling places and polling stations be amended as per Appendix A, namely:</p> <ol style="list-style-type: none"> <li>1. That the polling station for polling district BNA in the Britwell &amp; Northborough ward be relocated from Britwell Hub to Britwell Community Centre, due to the planned refurbishment of Britwell Hub.</li> <li>2. That the double polling station for polling district CHB in Chalvey ward be relocated from Brook House to Chalvey Community Centre in order to return the polling station to its more usual location following the refurbishment of the Community Centre, and that it become a single station in order to manage the flow of electors within the available space in a covid-safe manner.</li> <li>3. That the polling station for polling district ELA in Elliman ward be relocated from James Elliman Academy to Arbour Park Stadium in order to avoid the temporary closure of the school. Arbour park is located on one of the roads which form a boundary of the polling district, but outside the boundary of the polling district. No other suitable venue has been identified within the polling district and it is considered that in the circumstances this polling place is suitably well known and accessible for use.</li> <li>4. That the polling station for polling district ELB in Elliman ward be relocated from Littledown School Hall to the Salvation Army Hall in order to avoid the potential temporary closure of the school.</li> <li>5. That the polling station for polling district LKC in Langley Kedermister ward be relocated from Holy Family School to a temporary structure in the Harvester car park in order to avoid the potential temporary closure of the school.</li> <li>6. That the polling station for polling district LMB in Langley St Mary’s ward be relocated from the Langley Heritage Primary School Hall to a temporary structure in the Langley Heritage</li> </ol>

	<p>Primary School car park in order to avoid a potential temporary closure of the school.</p> <p>7. That the polling station for polling district LMC in Langley St Mary's ward be relocated from the Langley Leisure Centre to a temporary structure in the Langley Leisure Centre car park in order to provide for a suitably covid-safe polling station. While the leisure centre appears to have robust public health measures in place to ensure the safety of its users, the layout of the available space did not allow for preservation of those public health measures if it were also in use as a polling station.</p> <p>8. That the polling station for polling district UPA in Upton ward be relocated from St Bernard's Catholic Grammar School to a temporary structure on open space on Middlegreen Road in order to avoid the potential temporary closure of the school.</p> <p>9. That the polling station for polling district CHA in Chalvey ward be relocated from Claycots Academy (town hall) to the Slough Ice Arena in order to avoid the potential temporary closure of the school campus.</p>
<b>Reasons for taking decision</b>	<p>Summary reasons are given in the section above.</p> <p>These changes to polling stations arise from the Returning Officer's duties and powers in law to ensure the delivery of an accurate, fair and efficient election, and the various temporary requirements placed on organisations and individuals for public health reasons during the current pandemic.</p>
<b>Options considered</b>	<p>The previous locations for each polling place are listed above. In each case the option was to either keep the current location or move the polling place as set out.</p>
