21. Declaration of Interest

None.

22. Minutes

The Minutes of the meeting of the Licensing Committee held on 24th February, 2010 were taken as read and signed as a correct record. Members noted that the recommendation with regard to review of delegated powers would be reported to the June Council meeting.

23. Sexual Entertainment Venues

The Licensing Manager introduced the report that had been circulated as part of the agenda detailing the proposed legislative changes affecting the licensing of lap dancing and pole dancing clubs and similar venues. The Licensing Manager drew the Committee's attention to an error in the report in that the report should refer to Section 27 of the Policing and Crime Act 2009 and not Section 26. The report set out the details of the legislative proposals contained within Section 26 which introduced a new category of 'Sex Establishment' under Schedule 3 to the 1982 Act called a 'Sexual Entertainment Venue'.

The report summarised the amendments to Schedule 3 to the 1982 Act and members were advised that the new legislative provisions took effect from 6th April 2010. Members were advised that the Council had originally adopted the previous provisions of the Local Government (Miscellaneous) (Provisions) Act 1982 (LGMPA 1982) on the 19th March, 1984 and the Council would now need to adopt the new provisions which had been inserted into Schedule 3. The Council's Policy in relation to 'Sex Establishments' would require revision in order to incorporate Sexual Entertainment Venues and there may need to be a new separate policy.

The Licensing Manager detailed the proposed implementation which would include a transitional period which would last for 12 months and start on the date the amendments to Schedule 3 to the 1982 Act came into force in the relevant local authority area. The Council was currently waiting for relevant guidance to be produced by LACORS and further reports would be submitted to the Committee in relation to the adoption of the provisions under the 1982 Act, fees, standard terms and conditions, application forms and procedures

and amendments to the Policy. It was hoped that this report could be submitted to the July or September meeting of the Committee.

In noting these proposals Members sought clarification of the status of stripograms in pubs and similar premises and the Licensing Manager advised that he would think that this type of activity was likely to fall within the exemptions under the new proposals, however, the Council was waiting for further guidance on the detail of the new legislative provisions.

5. **Supporting Information**

- 5.1 At its meeting on 31st May, 2006 the Licensing Committee established a Licensing Sub-Committee and agreed its terms of reference as set out in appendix.
- 5.2 The Committee agreed to the appointment of designated Chairs of the Sub-Committee and that these Members would chair the meetings of the Sub-Committee on a rota basis.

- 5.3 It was also agreed that the Sub-Committee would consist of three Members to be drawn on a rota basis from the Members of this Committee on a politically proportionate basis. It should be noted that, as the Labour Group has an overall majority on the Council, the Sub-Committee will comprise two Labour Members and one Member of the BILLD Group.
- 5.4 Members are requested to establish a Licensing Sub-Committee, with the terms of reference as attached in the appendix, and to appoint three designated Chairs to the Sub-Committee for the municipal year 2010/11 (two Labour and one BILLD).

PROPOSED INCREASE IN HACKNEY CARRIAGE FARES

1. Purpose of Report

To consider a request from the Slough Taxi Drivers Union, to increase the approved hackney carriage fares.

2. **Recommendation** That the Committee:

- Approve the requested fare increase.
- Approve part of the requested increase.
- Approve a different increase to that proposed.
- Do not approve the requested increase and leave the fares as they are currently.

3. Community Strategy Priorities

- Being Safe, Feeling safe
- Prosperity for All

4. Other Implications

(a) Financial

Should the fare increase be approved, the Council has an obligation to publish details in the local paper. Any person may write in with a representation against the fare increase and, should this happen, all representations will be presented to the Licensing Committee who shall decide whether or not to modify the proposed table of fares. In any event, the table of fares (whether modified or not) shall come into force within two months from the date that the fare increase was to take effect as stated in the advertisement.

On 25th January, 2007 the Licensing Committee approved that:

"The costs of advertising the fare charges in the local newspapers are to be met by the hackney vehicle proprietors from the next submission of proposed fare increases". The Slough Taxi Drivers Union has confirmed that the cost of the advertisement for this increase will be divided by the 107 proprietors and payable at the next renewal of their licence.

(c) <u>Human Rights Act and Other Legal Implications</u>

Section 1 and Schedule 1 Parts I & II of The Human Rights Act 1998 apply:

Article 1 – Every person is entitled to the peaceful enjoyment of his or her possessions including the possession of licence and shall not be deprived of the possession except in the public interest

Article 6 – That in the determination of civil rights and obligations everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial tribunal established by law.

Local Government (Miscellaneous Provisions) Act 1976:

Section 65 of the Local Government (Miscellaneous Provisions) Act 1976 states;

- 1) A District Council may fix the rates or fares within the district as well for time as distance, and all other charges in connection with the hire of a vehicle or with the arrangements for the hire of a vehicle; to be paid in respect of the hire of a hackney carriage by means of a table (hereafter in this section referred to as a 'table of fares') made or varied in accordance with the provisions of this section
- 2) When a District Council make or vary a table of fares they shall publish in at least one local newspaper circulating in the district a notice setting out the table of fares or the variation thereof and specifying the period, which shall not be less than fourteen days from the date of first publication of the notice, within which and the manner in which objections to the table of fares or variation can be made

(d) Equalities Impact Assessment

It is important that the Council through its licensing functions protects the public by ensuring that the fares charged by licensed Hackney Carriages are fair and justified and not excessive.

5 Supporting Information

- 5.1 On 3rd February 2010 the Slough Taxi Drivers Union requested a fare increase from that previously approved in 2008.
- 5.2 The changes requested are as follows;
 - Section 1 Initial timing reduced from 120 seconds to 101 seconds and all Tariffs remain the same.
 - Section 2 Additional timing increased from 80 seconds to 120 seconds.
 Tariffs 1 to 5 increased by 20p, 60p, 20p, 30p and 40p respectively.
 - Section 3 Tariffs 1 and 2 reduced by £1.40, Tariff 3 reduced by £1.90 and Tariff 4 reduced by £2.80.
 - Section 4 A new section with new yardage of 460 yards and timing of 60 seconds.
 - Section 5 Tariffs 1, 2, and 4 remain unchanged and Tariff 3 reduced by 60p.
 - Section 6 A new section similar to that in section 4 in 2008 Fare Tariff. Timing reduced from 80 seconds to 60 seconds. All Tariffs r4emain the same.
 - Section 7 A new section with new tariffs.
 - Section 8 A new section with new yardage of 133 yards and timing of 60 seconds.
 - Section 9 All Tariffs increased by 20p.
 - Section 10 All Tariffs increased by 20p.
 - Old Tariff 2 of the 2008 Fare Tariff has been removed and has been detailed at the bottom of the new proposed fare Tariff as follows: **Daily, between 10pm and midnight, driver to add 40p extra to Tariff 1.**

6 Conclusion

Taking all the information into account the Committee are asked to determine whether the requested fare increase should be approved and, if so, that the hackney carriage trade pay for the advertisement of said fares.

The recommendation of this report is that if the Licensing Committee deems the fares to be fair and proportionate, that the requested increase is approved. However, the Committee should read this report and consider any representations made by any persons before making their decision.
