23. Minutes of the last meeting held on 8th February, 2012

Resolved - That the minutes of the previous meeting be approved subject to an amendment made on item 15.

24. NASACRE AGM - Jo Fageant

Jo Fageant, Chair of the Slough SACRE reported to the Committee on the Annual General Meeting of the National Association of SACREs (NASACRE) held on 23rd May. Professor Robert Jackson of the University of Warwick, amongst other speakers, spoke about Religious Education (RE) projects across UK and Europe. The Chair encouraged the Committee to view the minutes of the meeting on the NASACRE website.

The Committee was also given information about the upcoming review of the non-statutory national framework for RE. The Religious Education Council (REC) of England and Wales would also soon be introducing an RE Quality Mark (REQM) to recognise good practice in RE. Furthermore, an All Party Parliamentary Group on RE had recently been established and national groups on RE would be working with this newly launched body.

Resolved - That the update on the NASACRE AGM be noted.

25. Religious Education Council AGM - Jo Fageant

The Committee received a short update from the Chair, Jo Fageant on the Religious Education Council AGM, on which she sat as the National

representative of SACREs. The Schools Minister, Nick Gibb spoke at this meeting and had invited the REC to produce guidance on what made good RE teaching. The Chair encouraged the Committee to view the minutes of the meeting on the REC website.

Resolved - That the update on the REC AGM be noted.

26. LA Support and budget update

The Clerk updated the Committee on the support from the Local Authority to the SACRE in terms of budget and personnel. The Clerk had recently been informed by the Assistant Director, Inclusion, Robin Crofts that it had been agreed that Mrs Maggie Stacey, Headteacher of St Anthony's RC Primary School would now provide this support to the SACRE on behalf of the Local Authority.

The Committee also expressed concern over the lack of information provided on the budget and requested that this be followed up after the meeting.

Resolved - That the update on Local Authority support and budget be noted and that further information be sought on funds available.

27. Syllabus publication and launch

The Chair briefly outlined the progress made on the syllabus publication and launch, though further detail was held back for the meeting of the Agreed Syllabus Conference due to take place following the SACRE. It had been proposed that Slough Borough Council combine the launch of their syllabus with the Royal Borough of Windsor and Maidenhead.

Resolved - That the update on the syllabus publication and launch be noted.

28. Date of the next meeting - 22nd October, 2012

Resolved - That the next meeting be held on 22nd October 2012. A few of a members suggested that future SACRE meetings not be held on Mondays as this was not convenient for all. It was also agreed that the next agenda would include an item on Religious Education training.

7. Minutes of the last meeting held on 8th February, 2012

Resolved - That the minutes of the previous meeting be approved.

8. Presentation on the final draft of the revised RE syllabus

The Chair, Lynda Bussley, invited Jo Fageant, Chair of the Slough SACRE to present the final draft of the revised syllabus for Religious Education for Slough schools. The full draft document was presented to all members shortly before the meeting and this document was referred to during the presentation.

Meetings between teachers, faith groups and other interested parties had taken place to improve the document. A successful meeting for members of Christian Denominations and Other Faiths (Committee A) had been held on March 19th. This meeting had allowed this group to make contributions to the draft, such as to amend the key faith concepts, and members who attended this meeting were thanked for the contribution. Members of all faith groups, including those from the Slough SACRE had also contributed to support materials for teachers, which were available on the internet.

Key areas of the syllabus were outlined. These included the non-compulsory methods for planning lessons, the continued use of an eight level scale for attainment descriptors and the foundation stage section, much of which had remained the same as the previous syllabus. It was emphasised that the theme and intention of the guiding questions for the syllabus was for pupils to "learn about religion" and "learn from religion". Also outlined was the higher key stages, including the provision for 16-19, which set a basic minimum of six hours a year of teaching of the subject and the appendices of the syllabus

which outlined compulsory questions and what would expected that children would learn and achieve in their studies.

It was noted that no teaching staff from Slough schools had contributed to the pedagogic side of the syllabus review. Consultants working with Reading Borough Council and Wokingham Borough Council had worked on the design of the final document.

The Chair thanked Jo Fageant for presenting the syllabus and it was proposed that the approval of the syllabus be put to a vote.

Resolved - That the presentation of the final draft of the revised syllabus for religious education be noted and that the syllabus be put to a vote for approval.

9. Vote to decide whether to accept the revised syllabus

The Chair proposed that the agreed syllabus be put to a vote. All Committees that made up the Agreed Syllabus Conference agreed to approve the syllabus and to recommend to Cabinet that the syllabus be formally approved for introduction into Slough's schools from 1st September, 2012.

Recommendation - That Cabinet be asked to formally approve the revised Agreed Syllabus for Religious Education for introduction into Slough's schools from 1st September, 2012.

I am grateful to all members of the SACRE for their interest and commitment. It is with sadness that we have said goodbye to some long serving members but we look forward to our partnership with new people who are joining us for the next projects we hope to undertake.

Introduction

Slough Borough Council became a Unitary Authority with responsibility for education on 1st April, 1998. The Slough Standing Advisory Council on Religious Education (SACRE) was established from that date. This report covers the period 1st September, 2011 to 31st August, 2012 and represents the eleventh full year of SACRE's work.

Meetings

SACRE met three times during the 2011/12 academic year on 12th October, 8th February and 16th June. These meetings took place at Slough Town Hall; The Centre, Farnham Road and Chalvey Community Centre. Each meeting was followed by a meeting of the Agreed Syllabus Conference, which was convened by the Local Authority to review the Locally Agreed Syllabus for the year.

Membership

Jo Fageant was elected Chair for the 2011/12 academic year. Prior to its June meeting, Maggie Stacey, Headteacher of St Anthony's RC Primary School was appointed by the Local Authority to provide specialist support the SACRE.

In May 2011 the Authority appointed the Councillors Bains, Basharat, M S Mann and Munawer to serve as its representatives for the 2011/12 municipal year. In May 2012, the Authority reappointed Councillor M S Mann and appointed Councillors Aujla, Bains, Brooker Mann and Wright for the 2012/13 municipal year.

The SACRE made efforts to fill a number of vacancies on the SACRE during the year with the aim of broadening its representation of the different faith groups in Slough. As a result, a number of new members were appointed to the Slough SACRE:

- Ms Zara Choudhary (Islam)
- Mr Moulana Saeed Ziaee (Islam)
- Mrs Julie Siddiqui (Islam)
- Mr Hardip Singh Sohal (Sikhism)

Reverend Alan Bignell retired from the SACRE prior to the June meeting., leaving one vacancy for a representative of the Church of England. Vacancies also remain for representatives of Sikhism, the Black Free Churches and a number of teachers' bodies. A full list of members together with their attendance records is attached as Appendix 3.

Demographics of Slough

The Slough Unitary Authority area comprises 140,200 persons (2011 Census). The total school population of Slough, excluding independent schools, was 25,676 as counted in the 2012 School Census. The following schools are situated within the Slough area:-

Slough has four selective Grammar schools and fifteen academy schools (eight primary and seven secondary). Slough also has one free school, The Langley Hall Primary Academy.

Another factor which differentiates Slough from many other areas is its high ethnic minority population. This is vividly demonstrated by the ethnic origin of school pupils in Slough. The table on the next page shows the latest information on Slough pupils collected by the 2012 January School Census:

Also of interest is the home religion of Slough school pupils, with some 30% of those surveyed describing themselves as Christian as based on the January 2012 School Census. When Slough SACRE was established in 1998, the proportion describing themselves as Christian was just over half.

Religious Education

Developments in RE in Slough have mainly focused on the review and revision of the locally agreed syllabus. The review was shared with five other local authorities and invited the engagement of teachers and people of faith from all six authorities. Debate was lively and extremely positive and productive. The final document grew from the last syllabus and its links with the Non-statutory Framework for Religious Education (2004) remain clear. The religions required to be studied at each key stage remain unchanged. The key questions that make up the heart of the syllabus have strengthened the emphasis on enquiry-focused learning and the essential balance of 'learning about' and 'learning from' religion. The document will be printed and distributed to schools at the start of the new school year.

Teachers in Slough schools have had opportunities to attend a variety of RE related training. They were invited to join colleagues from Windsor and Maidenhead in three twilight sessions which introduced them to how the new syllabus was developing, how art might be used to enrich RE, and how issues of global citizenship, as exemplified in the materials published by RISC, could be investigated in the context of RE. They also had the opportunity to attend courses provided by the Diocese of Oxford: 'A philosophy for children approach to RE'; 'Identifying and providing for able, gifted and talented pupils in RE'; 'Ideas for assessment in RE'.

The SACRE has received regular updates on national developments and concerns relating to religious education. It discussed the concerns raised about the absence of RE from the subjects of the English Baccalaureate and the omission of the subject from the government's review of the curriculum.

The SACRE has expressed its concern that with the reduction of staff in the local authority it now receives almost no support other than the excellent contribution of the clerk. Members are very grateful for the partnership provision offered by the Royal Borough of Windsor and Maidenhead and the Diocese of Oxford.

Collective Worship

During 2011/12, the SACRE was not asked to approve or renew any request for a determination on collective worship. A list of those schools granted a determination by Slough SACRE is given below:

Renewals of determinations on collective worship are due every five years.

Links with Other Bodies

SACRE is affiliated to the National Association of SACREs (NASACRE). The current Chair of the SACRE serves on the executive of the National Association of SACREs (NASACRE) being its secretary and also one of its representatives on the RE Council of England and Wales. This enables her to be well informed about national initiatives within the RE community and bring them to the Slough SACRE. She is also the RE Adviser for the Anglican Diocese of Oxford and is able to bring the developmental work she does in that role to inform discussions and plans to support Slough schools.

Budget and Professional Support

The cost of administering SACRE in 2010/11 was minimal. Administrative support costs were absorbed within the Council's own budgets. The SACRE has been supported during the year by Simon Fullwood (Clerk).

Appendix 1 - The Legal Context

The Standing Advisory Council on Religious Education

Section 11 of the Education Reform Act 1988 (as amended by Section 255 of the Education Act 1993) places a duty on Local Authorities to establish a Standing Advisory Council on Religious Education (SACRE) in accordance with requirements laid down in that Section. The constitution of the SACRE is approved by the Education Committee (or equivalent).

An Authority must also establish an Agreed Syllabus Conference (ASC) under the provisions of Schedule 5 to the Education Act 1944 for the purpose of reviewing the agreed syllabus for religious education every five years. The two bodies are legally separate. The Authority must convene the Conference to produce and recommend an agreed local syllabus for RE.

Sections 255(2) and 254(3) of the Education Act 1993 respectively require authorities to review the membership of group A (Christian denominations and other religions) of their SACRE and the corresponding Committee of their Conference, so that the representation of each denomination or religion shall "so far as is consistent with efficient discharge of the group's (Committee's) functions, reflect broadly the proportionate strength of that denomination or religion in the area."

Members of SACRE are appointed by the Local Authority.

The Annual Report of the SACRE must be presented to the Local Authority each year.

SACRE's main function is "to advise the authority upon such matters connected with religious worship in its schools and the religious education to be given in accordance with an agreed syllabus as the authority may refer to the Council or as the Council may see fit".

It can also:-

- Require the LA to review its current agreed syllabus;
- Consider applications made by a headteacher for a determination of exemption from the broadly Christian character of collective worship.

(Education Reform Act 1988 S11(1)(a), S11(7), S12(1).)

The Agreed Syllabus for Religious Education

The Education Reform Act 1988 requires that:

- Religious Education should be taught to all pupils in full time education except for those withdrawn at the request of their parents (details to be found in Religious Education in English schools: Non-statutory guidance 2010, pages 17 and 27)
- Religious Education in county and voluntary controlled schools should be taught in accordance with an agreed syllabus
- As part of the curriculum, Religious Education should promote the "spiritual, moral, cultural, mental and physical development of pupils"
- An agreed syllabus should "reflect the fact that the religious traditions in Great Britain are in the main Christian whilst taking account of the teaching and practices of the other principal religions represented in Great Britain" (Education Reform Act, Section 8(3))
- The Education Act 1996 states agreed syllabuses in any community school and any foundation, voluntary-aided or voluntary-controlled school without a religious character cannot require RE to be provided by means of any catechism or formulary which is distinctive of a particular religious denomination (Schedule31, para 4)

Appendix 2 - Constitution

SLOUGH STANDING ADVISORY COUNCIL ON RELIGIOUS EDUCATION

The SACRE is established in accordance with Section 11 of the Education Reform Act 1988 (as amended by Section 255 of the Education Act 1993) by Slough Borough Council acting as Local Authority.

Membership

1. The Members of the SACRE shall be appointed by the Authority so that they shall represent the following groups.

Committee 1 – Christian denominations and other religions (12)

- The Free Churches (1)
- The Black Free Churches (1)
- The Roman Catholic Church (1)
- Hinduism (1)
- Islam (4)
- Judaism (1)
- Sikhism (2)
- Baha'is (1)

Committee 2 - The Church of England (4)

Committee 3 – Associations representing teachers (6)

- National Union of Teachers
- VOICE
- National Association of Head Teachers
- Association of School and College Leaders
- NASUWT
- Association of Teachers and Lecturers

Committee 4 – The Authority (5)

- 2. Committee 4 shall be subject to the proportionality requirements of the Local Government and Housing Act 1989.
- 3. No Member appointed to the Cabinet shall be appointed to the SACRE.

- 4. The SACRE shall be appointed by the Council.
- 5. Where a nominated representative fails to attend three consecutive meetings of the SACRE and fails to give their apologies s/he, shall cease to be a member of the SACRE and the nominating body shall be invited to nominate another representative provided that:
 - (a) the Clerk to the SACRE has advised the member in writing of the provision of this clause following the second missed meeting and at least a 10 working days before the third meeting.
 - (b) SACRE does not decide to disapply this rule for reasons of extenuating circumstances.

Terms of Reference

- 1. In accordance with Section 11 of the Education Reform Act 1988 (as amended by Section 255 of the Education Act 1993) to advise the Council on such matters connected with religious worship in schools and the religious education to be given in accordance with an agreed syllabus as the authority may refer to it or as it may see fit. To advise, in particular, on methods of teaching, the choice of materials and the provision of training for teachers.
- 2. On application made by a Head Teacher of any Slough school after consultation with the governing body to consider whether it is appropriate for the requirement for Christian collective worship to apply in the case of that school, or in the case of any class or description of pupils at that school. The SACRE shall arrive at its decision and communicate it to the Head Teacher in accordance with the provisions of Section 12 of the Education Reform Act 1988.
- 3. The representative groups on the SACRE other than that representing the authority may at any time require a review of any agreed syllabus for the time being adopted by the authority.
- 4. The SACRE shall each year publish a report on its proceedings and those of its representative groups, the report to specify any matters on which the SACRE has given advice to the authority and the reasons for offering that advice.
- 5. The SACRE shall take any action assigned to it by the authority in relation to the consideration and disposal of any complaint concerning worship or religious education in compliance with Section 23 of the Education Reform Act 1988.
