#### 20. Declarations of Interest

None were received.

### 21. Minutes of the Meeting held on 8 March 2012

The minutes of the meeting held on Thursday, 8<sup>th</sup> March 2012 were approved as a correct record.

# 22. Application to Vary Premises Licence - Co-Operative, 238-240 Trelawney Avenue, Slough

The Chair welcomed all parties to the meeting and outlined the procedure for the hearing. It was confirmed that all parties had received a copy of the agenda for the meeting.

### Introduction by the Licensing Officer

Mr Idowu, Licensing Officer introduced the report on the application made by Co-operative Group Food Ltd, to vary a Premises Licence for 'Co-operative' at 238-240 Trelawney Ave, Langley, Slough, SL3 7UD.

The application to vary the licensable activities were outlined and it was explained that the authority had received no objections from local residents on the proposed variation.

Mr Idowu also briefly outlined the representations made by the responsible authorities. Ms Pearmain of Thames Valley Police had agreed with the premises request that CCTV footage would be kept by the premises for 30 days, instead of the usual 31 days due the system used by the Co-Operative. Further to this, it was explained that the licence holder application had been altered so that the times that the premises would supply alcohol would be changed to Monday to Sunday, 07.00 to 22.00.

Mr Idowu also outlined the representations made by Mr Palacio – Team Leader, Neighbourhood Enforcement. Mr Palacio had responded to the application and requested that the Council's "Can Marking Scheme" be made a formal requirement on the Premises Licence to enable alcohol cans and bottles to be linked to the premises and provide "prima-facie" evidence to enable investigation by the licensee to refuse sales to underage or individuals.

The relevant guidance and policies were outlined for Members consideration. Options available to the Sub-Committee were also highlighted.

#### Questions to the Licensing Officer

Members asked questions of Mr Palacio regarding the appropriateness of imposing the "Can Marking Scheme" on the Premises Licence. Mr Palacio responded that the Neighbourhood teams had encountered Anti-Social Behaviour in the locality and it was his intention that the scheme be extended so that 'prima-facie' evidence on any premises selling alcohol to minors could be gathered.

A Member asked whether there was evidence if the premises in question had breached their licence so far, Mr Palacio explained that there was no evidence that this had occurred at this particular premises. However, it was explained that there were concerns about surrounding premises and that the Neighbourhood Enforcement team wished to work with the Co-Operative to extend the scheme to all premises in the area. The Co-Operative was currently taking part in the scheme as a voluntary measure.

#### Representations by the Premises Licence Holders

A legal representative of the Premise Licence Holders was in attendance. The representative outlined the steps taken by the Co-Operative to ensure that all licensing objective were adhered to and enforced. He explained that the premises has a 'Challenge 25' policy and there were usually at least three Premises Licence Holders on site at one time. He also outlined the amended hours in the application of Monday to Sunday, which were now 07:00 to 22:00.

The representative also outlined the Premises Licence Holder's objections to the placing of the Council's "Can Marking Scheme" as a formal requirement on the Premises Licence. It was argued that this condition would be difficult to enforce and it was not proportionate or necessary given that there had been no breach of the licence. It was also explained that the premises was currently taking part in the scheme voluntarily.

#### Questions to the Premises Licence Holder representative

In discussion with Members, a number of questions were asked of the Premises Licence Holders relating to their processes for ensuring that there were no sales of alcohol to minors. These were clarified further for the Sub-Committee.

With regard to the Council's "Can Marking Scheme", the representative reiterated the points made earlier. It was also explained that cans of alcohol already had batch numbers by which they could be identified and linked to a particular store, referring to a scheme currently followed in Durham.

It was suggested by Ms Pearmain that it a condition could be placed on the Licence that the premises would be obliged to follow the 'Can Marking Scheme' if officially requested. The representative of the Premises Licence Holder stated that he was not in a position to agree this condition.

#### Summing Up

All parties were given an opportunity to provide a brief summary. The Licensing Officer outlined the options available to the Sub-Committee, the representations of Mr Palacio, and the amendments that had been requested by the Premises Licence Holder. The Sub-Committee's attention was drawn to section 182 of the guidance that any decision must be necessary, relevant and proportionate. The representative of the Premises Licence Holder did not take the opportunity to sum up.

All parties were asked to leave the meeting whilst the Sub-Committee deliberated.

#### Decision

Having carefully considered all the information available, the Sub-Committee decided to **grant the variation** of the premises licence subject to the relevant mandatory conditions consistent with the application made and those made by Thames Valley Police. These were as follows:

- (M) Supply of Alcohol (Off the premises only)
   Monday to Sunday 07.00 22.00.
- (O) Hours the premises are open to the public Monday to Sunday 06.00-23.00
- CCTV to be installed and maintained to Thames Valley Police standard and CCTV to be kept for 30 days and made available upon the request of Thames Valley Police employees and relevant agencies.
- DPS or nominated person to be trained on how to work the CCTV system to the standard where the nominated person can download any potential evidence required by Thames Valley Police employees or relevant agencies.

In reaching this decision, Members considered the conditions to be necessary, reasonable and proportionate to address concerns relating to crime and disorder, public nuisance and public safety.

# 23. Review of Premises Licence - Alexandra Wines, Unit 4 Alexandra Plaza, Chalvey Road West, Slough

The Clerk informed the Sub-Committee that the Premises Licence Holder had contacted Democratic Services to request an adjournment of consideration of the matter. The Premises Licence Holder attended the meeting to give his reasons for requesting an adjournment. He had not been in the country so had not received papers notifying him of the hearing until three days prior to

the meeting, and as such he did not have enough time to arrange legal representation.

**Resolved** – That consideration of agenda item 3 – Review of Premises Licence for Alexandra Wines – be adjourned to the next meeting of the Licensing Sub-Committee.

# 24. Review of Premises Licence - Drinks Direct Supermarket Limited, 256 High Street Langley, Slough

All parties were welcomed to the meeting and following introductions, the procedures for the hearing was explained. It was confirmed that all parties had received a copy of the relevant paperwork.

### Introduction by the Licensing Officer

Mr Idowu informed Members that Drinks Direct Supermarket Limited operated under a premises licence which authorised the sale of alcohol at 08:00 to 23:00 on Monday to Saturday and 10:00 to 22:30 on Sunday. In February 2012 Slough Borough Council's Trading Standards Service had submitted an application for the Review of the Premises Licence on grounds of the Prevention of Crime and Disorder, Public Safety and the Protection of Children from Harm.

The grounds for the Review Application were selling alcohol to an underage person, selling cigarettes to an underage person, selling fireworks in breach of the firework licence conditions, and found in possession for sale of counterfeit alcohol, condoms and batteries.

An outline of the relevant guidance and options available were highlighted for Members consideration.

#### Questions to the Licensing Officer

None

#### Representations on behalf of Slough Borough Council, Trading Standards

Jaspal Singh, Senior Technical Enforcement Officer, Trading Standards Service, submitted evidence to the Sub-Committee and the grounds for requesting a review of the premises licence. Mr Singh outlined a history of the premises, referring to a number of incidents relating to the sale of counterfeit items, sale of alcohol to underage persons and the sale of fireworks outside the permitted time period.

Mr Palacio, Team Leader, Neighbourhood Enforcement, explained that the BottleWatch Scheme enabled the police to identify where alcohol had been purchased from as products were marked with a UV marker which was specific to that premise.

It was the recommendation of Slough Borough Council's Trading Standards Service that in light of these incidents, the premises licence be revoked.

#### Questions to Slough Borough Council, Trading Standards

Members of the Sub-Committee questioned Mr Singh on a number of points made in his submission. Mr Singh confirmed for the Sub-Committee that the incidents regarding the sale of counterfeit goods had taken place in 2007. The test purchase exercise in which alcohol was sold to an underage volunteer and the test purchase of fireworks outside of the permitted time period were both made in November 2011

#### Representations by the Premises Licence Holder

The Premises Licence Holder and his representative addressed the Sub-Committee. The representative stated that there was no evidence that counterfeit goods had been sold since the incident in 2007. Further to this, it was emphasised that this incident was an isolated one. The representative also submitted that the License Holder had made an error of judgment when making the sale of alcohol to an underage person and the sale of fireworks outside the permitted time period and that he would ensure rigorous checks were carried out in the future. The representative also presented a number of proposed conditions which related the installation of CCTV recording equipment and the Council's "Can Marking Scheme", which were noted by the Sub-Committee.

#### Questions to the Premises Licence Holder

In the ensuing discussion, the Premises Licence Holder and representative were questioned on the 2007 incident of sale of counterfeit items. The Licence Holder claimed at this time there was counterfeit alcohol being sold in the market, and he had been a victim of this. The representative emphasised that he was in the process of organising training for the staff at the premises so that the licensing objectives were enforced.

The Premises Licence Holder also submitted that he had already taken part in the "Can Marking Scheme" which was confirmed by Mr Palacio.

#### Summing Up

A short summary was provided by all parties following which they left the meeting in order for the Sub-Committee to deliberate.

#### Decision

All parties were asked to re-join the meeting.

Having carefully considered all the information available, the Sub-Committee decided to impose the following on the Premises Licence:

- 1. The Premises Licence Holder is required to undertake the requirements of the Council's can-marking scheme.
- 2. CCTV to be installed and recordings to be kept for 31 days (compliant with Home Office regulations) and made available upon the request of Thames Valley Police or the Licensing Authority.
- 3. Staff to be trained on how to work the CCTV system where a staff member can download any potential evidence if required by Thames Valley Police or the Licensing Authority.

In accordance with Central Government guidance and due to the seriousness of the incident highlighted the Sub-Committee also decided to issue the premises with a "Yellow Card". It was highlighted that if a further review was necessary and matters had not improved, the premises licence could be revoked.

The Sub Committee considered the conditions imposed to be necessary, reasonable and proportionate to address concerns relating to the prevention of crime and disorder and protection of children from harm.

Review of Premises Licence – **Number PL007381**Application made by Thames Valley Police

#### 1. CURRENT POSITION

- 1.1 RABZ Night Club operates under a Premises Licence number **PL007381** which is held by a company called M H Property Letting Limited. The sole named director of M H Property Letting Limited is Mr Majad Hussain.
- 1.2 The Designated Premises Supervisor (DPS) at the time of the Review Application being made by Thames Valley Police was also Mr Majad Hussain who holds a Personal Licence number 10/00497/LAPER with South Bucks District Council. Mr Hussain was also the manager of the premises
- 1.3 The DPS is responsible for the day to day management of the premises.
- 1.4 The Premises Licence authorises the carrying out of the Relevant Licensable Activities as follows:
  - E. Performance of live music (Indoors)
  - F. Playing of recorded music (Indoors)
  - G. Performance of dance (Indoors)
  - J. Provision of facilities for dancing (Indoors)
  - M The sale by retail of alcohol for consumption On the premises only
- 1.5 The licence authorises the Licensable Activities Friday to Sunday 9.00pm to 02.00 am and a copy of the current Premises Licence is attached at **Appendix A.**

#### 2. BACKGROUND INFORMATION

- 2.1 On 2<sup>nd</sup> May 2012 Thames Valley Police submitted an application for the Review of the Premises Licence on grounds of the Prevention of Crime and Disorder and Public Safety, the full Review Application is contained at **Appendix B** and the supporting evidence and additional supporting evidence supplied by the Police and, which has been sent to Mr Hussain are contained at **Appendices C, C-1, C-2, D, E, F and G respectively.**
- 2.2 The extensive grounds for the Review Application being made are detailed fully

within the application, however these can be summarised as;

- Serious issues of disorder and fights, inside the venue and outside by the venue's customers
- Complete lack of control by the Management
- Reports of customers leaving the venue at 03.45am
- Complaints of ongoing loud music by local residents
- Noise abatement notice issued by Slough Borough Council Environmental Protection Officer
- Intelligence of drugs at the premise
- Irresponsible drinks promotions being advertised on Face Book
- Premise advertising closing time of premise on Face Book as 4am
- Misleading applications for Temporary Events Notices
- Section 19 issued on the opening night
- Section 160 Order issued by a District Judge.

#### 3. <u>APPLICATION</u> – REVEW OF PREMISES LICENCE

- 3.1 The Licensing Authority is satisfied that this application for Review meets the appropriate legislative requirements within the Licensing Act 2003 and is therefore a valid application to be considered by the Licensing Sub-Committee.
- 3.2 The Review Application states as follows: Police Sergeant Hewitt has stated that this is the worst premise he has ever been in, in over 15 years service. I (Debie Pearmain) am of the same view and can report that in over 10 years of working as the Police Licensing Officer and dealing with over 1,000 premises, I have never experienced such issues and lack of control within such a short time of opening. Let us not forget this premise only opened on Friday 3<sup>rd</sup> February 2012. This cannot continue as the public safety licensing objective and Crime and Disorder licensing objective are being undermined.
- 3.2 The Review Application further states: Thames Valley Police's view that due to the catalogue of incidents and non-compliance at the premises and by the Designated Premises Supervisor the Premises Licence should be **revoked**.
- 3.3 If however, the Members are of the opinion that the Premises Licence should not be revoked, Thames Valley Police request the Premises Licence is suspended and the below amendments and extra conditions are placed along side the existing licence:
  - All licensable activity to cease at midnight on all days of the week.

- The closing hours of the premises to be 00.30am of all days of the week.
- Designated Premises Supervisor to be on the premises during all licensable activity.
- Thames Valley Police to be informed of all events with a minimum of 14 days notice to be given.
- Last admission time to be 11.00pm.
- Designated Premises Supervisor or Personal Licence Holder to be trained on how to work the CCTV System to the standard where the nominated person can download any potential evidence required by Thames Valley Police employees or relevant Agencies.
- Suitably qualified First Aider with appropriate first aid supplies to be on duty during all licensable activities.
- Polycarbonate glasses to be used.
- Incident Register to be in place and kept up to date and made available upon the request of Thames Valley Police and any Authorised Officer of the Council, and kept for a minimum of one year.
- All Staff members and SIA door staff to fully co-operate with Police Officers and make themselves available immediately upon the request of the Police Officer to give statements and provide CCTV.
- Door staff Signing in and out Register to be in place and made available upon the request of Thames Valley Police and any Authorised officer of the Council, and kept for a minimum of one year.
- Smokers to be limited to 10 persons at all times.

#### 4. REPRESENTATIONS RECEIVED

- 4.1 A written representation has been received from a local resident detailing continued noise from inside and outside the premises as well violent and aggressive behaviour and assaults occurring outside the premises. The full representation is contained at **Appendix H.**
- 4.2 A representation to the Review Application has been received from Ian Blake Team Leader of the SBC Neighbourhood Enforcement Team.
- 4.3 Mr Blake has submitted a formal Responsible Authority Representation Form which is contained at Appendix I, a written witness statement contained at Appendix J, a copy of a Section 80 Noise Abatement Notice contained at Appendix K, 2 DVD's showing CCTV footage of disorder out side RABZ Night Club which are detailed at Appendix L which will be produced and available for viewing at the Licensing Sub Committee hearing.
- 4.4 A summary of the evidence produced by Mr Blake since the premises opening

on 3<sup>rd</sup> February 2012 is as follows:

- On 20<sup>th</sup> February noise complaint of loud amplified music as well as disorder outside the RABZ
- On 27<sup>th</sup> February Officers attended noise complainant premises and witnessed loud base music from RABZ. The DPS could not be contacted.
- On 29<sup>th</sup> February Section 80 Noise Abatement Notice served
- On 11<sup>th</sup> March (also see Appendix J) Officer visited the noise complainants premises and witnessed amplified music and thumping base as well as continued crime and disorder issues outside RABZ which is clearly shown on the 2 DVD's (Appendix L)
- On 13<sup>th</sup> March meeting held with Mr Majad with the Police and Mr Blake and the Senior Licensing Officer
- On 15<sup>th</sup> March visit to RABZ and spoke with Mr Majad regarding his noise management plan.
- On 16<sup>th</sup> and 23<sup>rd</sup> March visits to the area were made witnessing noise in the street by customers from RABZ
- Further noise complaints were received on 27<sup>th</sup> April and 6<sup>th</sup> May.
- 4.5 There were no further responses from any other Responsible Authorities.

#### 5. RELEVANT GUIDANCE AND POLICIES

- 5.1 The relevant sections of the REVIEW PROCESS from the Section 182 Secretary of States Guidance is appended to the end of this report which the Committee must have regard to.
- 5.2 Under its statutory powers under the Act the Licensing Sub Committee may take any of the following steps:
- to modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
- to exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption);
- to remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;
- to suspend the licence for a period not exceeding three months;
- to revoke the licence.
- 5.2 The Sub-Committee should also consider and make use of the 'Yellow and Red Cards' system as directed and recommended by The Department of Culture, Media and Sport (DCMS).

#### THE REVIEW PROCESS

- **11.1** The proceedings set out in the 2003 Act for reviewing premises licences and club premises certificates represent a key protection for the community where problems associated with the licensing objectives occur after the grant or variation of a premises licence or club premises certificate.
- **11.2** At any stage, following the grant of a premises licence or club premises certificate, a responsible authority, or any other person, may ask the licensing authority to review the licence or certificate because of a matter arising at the premises in connection with any of the four licensing objectives.
- **11.3** An application for review may be made electronically, provided the licensing authority agrees and the applicant submits a subsequent written application. The licensing authority may also agree in advance that the application need not be given in writing. However, these applications are outside the formal electronic application process and may not be submitted via Business Link or the licensing authority's electronic facility.
- **11.4** In addition, the licensing authority must review a licence if the premises to which it relates was made the subject of a closure order by the police based on nuisance or disorder and the magistrates' court has sent the authority the relevant notice of its determination, or if the police have made an application for summary review on the basis that premises are associated with serious crime and/or disorder.
- 11.5 Any responsible authority under the 2003 Act may apply for a review of a premises licence or club premises certificate. Therefore, the relevant licensing authority may apply for a review if it is concerned about licensed activities at a premises and wants to intervene early without waiting for representations from other parties. However, it is not expected that licensing authorities should normally act as responsible authorities in applying for reviews on behalf of other persons, such as local residents or community groups. These individuals or groups are entitled to apply for a review for a licence or certificate in their own right if they have grounds to do so. It is also reasonable for licensing authorities to expect other responsible authorities to intervene where the basis for the intervention falls within the remit of that other authority. For example, the police should take appropriate steps where the basis for the review is concern about crime and disorder. Likewise, where there are concerns about noise nuisance, it is reasonable to expect the local authority exercising environmental health functions for the area in which the premises are situated to make the application for review.
- **11.6** Where the relevant licensing authority does act as a responsible authority and applies for a review, it is important that a separation of responsibilities is still achieved in this process to ensure procedural fairness and eliminate conflicts of interest. As outlined previously in Chapter 9 of this Guidance, the distinct functions of acting as licensing authority and responsible authority should be exercised by different officials to ensure a separation of responsibilities. Further information on how licensing authorities should achieve this separation of responsibilities can be found in Chapter 9, paragraphs 9.13 to 9.19 of this Guidance.
- **11.7** Any application for a review received by the licensing authority from responsible authorities and any other persons should be given due consideration and treated by the authority in precisely the same way, regardless of the body or individual which made it. This includes an application made by the local authority acting in a separate capacity (for example, environmental health or child protection).
- **11.8** In every case, any application for a review must relate to particular premises in respect of which there is a premises licence or club premises certificate and must be relevant to the promotion of one or more of the licensing objectives. Following the grant or variation of a

licence or certificate, a complaint regarding a general issue in the local area relating to the licensing objectives, such as a general (crime and disorder) situation in a town centre, should generally not be regarded as a relevant representation unless it can be positively tied or linked by a causal connection to particular premises, which would allow for a proper review of the licence or certificate. For instance, a geographic cluster of complaints, including along transport routes related to an individual public house and its closing time, could give grounds for a review of an existing licence as well as direct incidents of crime and disorder around a particular public house.

- **11.9** Where a licensing authority receives a geographic cluster of complaints, the authority may consider whether these issues are the result of the cumulative impact of licensed premises within the area concerned. In such circumstances, the authority may also consider whether it would be appropriate to include a special policy relating to cumulative impact within its licensing policy statement. Further guidance on cumulative impact policies can be found in Chapter 13 of this Guidance.
- **11.10** Representations must be made in writing and may be amplified at the subsequent hearing or may stand in their own right. Additional representations which do not amount to an amplification of the original representation may not be made at the hearing. Representations may be made electronically, provided the licensing authority agrees and the applicant submits a subsequent written representation. The licensing authority may also agree in advance that the representation need not be given in writing.
- **11.11** It is important to recognise that the promotion of the licensing objectives relies heavily on a partnership between licence holders, authorised persons, responsible authorities and any other persons in pursuit of common aims. Where authorised persons and responsible authorities have concerns about problems identified at premises, it is good practice for them to give licence holders early warning of their concerns and the need for improvement, and where possible they should advise the licence or certificate holder of the steps they need to take to address those concerns. A failure by the holder to respond to such warnings is expected to lead to a decision to apply for a review. Co-operation at a local level in promoting the licensing objectives should be encouraged and reviews should not be used to undermine this co-operation.
- **11.12** If the application for a review has been made by a person other than a responsible authority (for example, a local resident, residents' association, local business or trade association), before taking action the licensing authority must first consider whether the complaint being made is relevant, frivolous, vexatious or repetitious. Further guidance on determining whether a representation is frivolous or vexatious can be found in Chapter 9 of this Guidance (paragraphs 9.4 to 9.10).

#### REPETITIOUS GROUNDS OF REVIEW

- **11.13** A repetitious ground is one that is identical or substantially similar to:
- a ground for review specified in an earlier application for review made in relation to the same premises licence or certificate which has already been determined; or
- representations considered by the licensing authority when the premises licence or certificate was granted; or
- representations which would have been made when the application for the premises licence was first made and which were excluded then by reason of the prior issue of a provisional statement; and, in addition to the above grounds, a reasonable interval has not elapsed since that earlier review or grant.

- **11.14** Licensing authorities are expected to be aware of the need to prevent attempts to review licences merely as a further means of challenging the grant of the licence following the failure of representations to persuade the licensing authority on an earlier occasion. It is for licensing authorities themselves to judge what should be regarded as a reasonable interval in these circumstances. However, it is recommended that more than one review originating from a person other than a responsible authority in relation to a particular premises should not be permitted within a 12 month period on similar grounds save in compelling circumstances or where it arises following a closure order.
- **11.15** The exclusion of a complaint on the grounds that it is repetitious does not apply to responsible authorities which may make more than one application for a review of a licence or certificate within a 12 month period.
- **11.16** When a licensing authority receives an application for a review from a responsible authority or any other person, or in accordance with the closure procedures described in Part 8 of the 2003 Act (for example, closure orders), it must arrange a hearing. The arrangements for the hearing must follow the provisions set out in regulations. These regulations are published on the Government's legislation website (www.legislation.gov.uk). It is particularly important that the premises licence holder is made fully aware of any representations made in respect of the premises, any evidence supporting the representations and that the holder or the holder's legal representative has therefore been able to prepare a response.

#### POWERS OF A LICENSING AUTHORITY ON THE DETERMINATION OF A REVIEW

- **11.17** The 2003 Act provides a range of powers for the licensing authority which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.
- **11.18** The licensing authority may decide that the review does not require it to take any further steps appropriate to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.
- **11.19** However, where responsible authorities like the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate.
- **11.20** Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:
- to modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
- to exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption);
- to remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;
- to suspend the licence for a period not exceeding three months;

- to revoke the licence.
- **11.21** In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response.
- **11.22** For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.
- **11.23** Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated by representations, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems that impact upon the licensing objectives.
- 11.24 Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as an appropriate means of promoting the licensing objectives. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.

#### **ANNEX 1 - MANDATORY CONDITIONS**

Condition 1, with effect 6th April 2010

- 1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act):
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
- (i) the outcome of a race, competition or other event or process, or
- (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

Condition 2, with effect 6th April 2010

The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

Condition 3, with effect 6th April 2010

The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

Condition 4, with effect from 1st October 2010

- (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

Condition 5, with effect from 1st October 2010

The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than

alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i) beer or cider: 1/2 pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml; and

(b) customers are made aware of the availability of these measures.

#### ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

#### CRIME AND DISORDER

#### Door supervision

- 1. Door Supervisors will be in attendance at the entrance of the premises from 21:00 hours until the main exit doors to the premises are closed, and at any time when patrons may be queuing for access.
- 2. All such individuals must be licensed by the Security Industry Authority (SIA).
- 3. A Door Supervisor register is kept and includes names, dates and times of the persons employed in such capacity. An incident register will be kept to record all incidents of disorder at the premises and immediately outside and the manager and member of staff involved in the incident must sign off the entry. These registers must remain on site at all times.
- 4. Door Supervisor ratio agreed by the Police and Licensing Authority, which is 1:100

- 5. Permitted occupancy level must not exceed 600 persons in total Ground floor up to 450 persons, First floor up to 200 persons.
- 6. All persons entering the premises to be searched by means of a metal detector by door staff on entry.
- 7. A female door supervisor will conduct searches on female customers.
- 8. 2 extra Door Supervisors shall be on duty from 1 hour before, during and 1 hour after times of drinks promotions.
- 9. A Personal Licence holder shall be on site at all times of operation.
- Admissions to the venue are to be made via the main front (High Street) entrance only.
- 11. No person under 18 years of age is allowed on the premises.
- 12. The current level of lighting outside the premises will continue to operate during the hours of trading.
- 13. Any person who appears to be intoxicated or who is behaving in a disorderly manner will not be allowed entry to the premises.
- 14. Any person within the premises who appears to be intoxicated or who is behaving in a disorderly manner will be given due care and consideration when leaving the premises.

- 15. The venue will actively participate in the local Pub Watch scheme.
- Reasonable steps will be taken to recognise the need of local residents and businesses.

#### **ADMISSION POLICY**

- 17. If Door staff have any doubt regarding the age of the customer or believes they may have used alcohol or an illegal substance they will not admit that person to the venue.
- 18. Any drink, weapon or illegal substance will be confiscated.
- 19. If the venue has any special dress code requirements this will be plainly publicised.
- 20. Management reserves the right to refuse admission.

#### CODE OF CONDUCT FOR STAFF

- 21. Should a difficulty occur with any customer staff will only use physical contact if absolutely necessary.
- 22. Staff will treat all people with resepect and dignity.
- 23. Staff will ensure that their welfare and safety is paramount at all times.
- 24. Staff will always act in a proffessional way.
- Staff will not accept bullying, swearing or other disruptive behaviour from any customer.

#### C.C.T.V.

- 26. A C.C.T.V. sytem will be installed working to the satisfaction of Thames Valley Police and the Licensing Authority.
- 27. C.C.T.V. recordings will be maintained for a period of 31 days.
- 28. The existing C.C.T.V. system will continue to operate during additional hours of trading.
- 29. Notices stating that C.C.T.V. is in operation 24 hours a day will be displayed throughout the venue and at the venue entance.
- 30. If the C.C.T.V. equipment fails, the Police and the Licensing Authority will be informed immediately by telephone and immediate steps will be taken to put the equipment back into working order.
- 31. At least one C.C.T.V. camera will be in operation at the front of the premises at all times when the premises is in use.
- 32. If a DJ is used on any night then he/she will ask customers to leave quietly.

#### Bottles and glasses

- 33. Contents of bottles used should be decanted prior to service to customers in toughened glass, or if any bottles are served to customers these are also to be made from toughened glass.

- 41. The equipment will be on at all times the premises are open to the public, and will be monitored by the Designated Premises Supervisor or other responsible staff member.

#### Capacity Limits

- 42. We have a capacity limit of 600 to prevent overcrowding which could lead to crime and disorder.

- 52. A secure area for customer's personal belongings is available.

#### **PUBLIC SAFETY**

- 53. This venue takes it's obligation under existing legislation seriously. the nature and operation of the venue will not alter during the additional hurs.
- 54. Bar staff and Door Supervisors to keep in contact via radio.

PC Simpson, Rachael Rumney, SBC Licensing and Debie Pearmain, Police Licensing Officer attended the premise to speak to Mr Hussain about the two separate complaints that Thames Valley Police had received about the facebook advertising. Mr Hussain was informed that this sort of advertising is not acceptable. We then went through the conditions on the premises licence and Mr Hussain was informed that all the conditions on the licence must be adhered to otherwise this would be a breach of licence. Mr Hussain assured me that all the conditions would be in place. I also informed him that I would be attending the premises on Friday 3<sup>rd</sup> February 2012 to check that the conditions were in place. He again assured me that this would be done.

PC Simpson, Licensing Officer, SBC and Debie Pearmain, Police Licensing Officer attended the premise to check the licence conditions were being adhered to. As we entered the premise it appeared to us to not be ready for trading. The best description for the venue was that it was like a warehouse, there was no proper flooring in place, we were informed that the CCTV was not working due to a leak, no heating (it was very cold in the venue) and there were limited drinks. Door staff SIA badges checked – all in order, no drugs register seen and no metal detector in place. I questioned one of the door staff about this as the DPS kept disappearing and he informed me that they could use a hand wand – advice given to use this. No door staff signing in and out Register in place. Mr Hussain was on site but kept disappearing and was not particularly helpful during our visit. Before we left the premise I informed Mr Hussain that we would be back to ensure that the CCTV was working and if it was not working action may be taken.

At approximately 11.00pm we returned back to the venue. Mr Hussain informed us that the CCTV was still not working and someone was working on it .When I asked to see the CCTV hard drive and cameras I was shown to a hole in the ceiling by the DJ booth, when I asked who was working on the system to fix it Mr Hussain pointed to a male, who was stood by the wall. The male came over, I then said to Mr Hussain, "Well he is not working on the CCTV now is he?" At that point both Mr Hussain and the male invaded my personal space and I had no other choice but to raise both my hands to signal to them both to move away from me. It was quite obvious that the CCTV was not going to be fixed and working. We then left the premise and I informed Mr Hussain that the Inspector would be attending the premise to issue a Section 19 Closure Notice of the Criminal Justice and Police Act 2001 for the breach of licence condition. At 11.23pm Sergeant Newsome served a Section 19 Notice on Mr Hussain, DPS. We had witnessed licensable activity during our visits, prior to the notice being issued.

I informed Mr Hussain that I had a Police Officer, Council Licensing Officer and myself waiting for him at the Police Station. He informed me that he was in High Wycombe and did not think that he had to come to the meeting, as we had attended the premise on Thursday last week. I informed Mr Hussain that I had not cancelled this meeting and that I was extremely disappointed that he had failed to turn up, particularly following the issue on Friday evening where the Section 19 notice had been issued. To date the CCTV was still not working. Mr Hussain informed me that he would not be opening this weekend and that he plans to open on Friday 17<sup>th</sup> February 2012. Mr Hussain was advised that the Police need to visit the premise to check that CCTV is working when this has been done a cancellation notice can be issued. I also informed Mr Hussain that I was very disappointed with the way we were dealt with on Friday evening during our licensing inspection. Mr Hussain stated that if we had turned up at 8.30pm he would have been able to spend more time with us. Mr Hussain had a very negative attitude towards me and if this is his attitude now it does cause Thames Valley Police concern as to the way the premise will be managed, it would appear that he does not want to work with the Police or Local Authority. I informed Mr Hussain that we would check the CCTV on Thursday 16th February 2012.

We went to the upstairs area and Sergeant Piper then informed Mr Hussain that he was not satisfied with the CCTV coverage upstairs and at this stage was not going to issue a cancellation notice for the Section 19.Mr Hussain was fully update of our concerns by the Sergeant. Mr Hussain informed us that the promoter only wanted to use the downstairs area. Sergeant Piper then stated that whilst the upstairs area was not being used, he requested that an extra camera was fitted and recording the stair area and if this was done, he would be satisfied. He also stated he would like physical barriers put in place at the top of the stairs, which was not covered by CCTV. Mr Hussain agreed to do this. I then informed Mr Hussain that Thames Valley Police would return Friday afternoon (the next day) to ensure that the extra camera and barriers were in place and if this was done a cancellation notice would be issued. Sergeant Piper also advised Mr Hussain of the trip hazard at the top of the stairs and advised him to rectify this. We left the premise at 3.35pm.

As I was walking along the High Street I was handed a flyer advertising and promoting RABZ. The following advertising on the flyer caused me concerns:

I telephoned Mr Hussain to check that the camera has been installed as per the Sergeant's request. Mr Hussain informed me that it had been installed.

At 2.15pm PC Williams, Rachael Rumney, Licensing Officer, SBC and I attended the premise. CCTV was checked and the extra camera had been installed. PC Williams issued the cancellation notice. I then proceeded to inform Mr Hussain of my concerns over the flyer and what was being advertised. I reminded him that the capacity was 650 and not 700. Rachael Rumney and I both informed him of our concerns in relation to the cheap drinks being advertised. Rachael Rumney informed him of the mandatory condition already on the premises

Licence concerning drinks promotions. I then informed Mr Hussain of my concern of the VIP area, as I knew that the upstairs area was not covered by CCTV. Mr Hussain informed me that the VIP area had been moved downstairs. I once again reminded Mr Hussain not to use the upstairs area until the CCTV was covering the licensable area and if he did so this would be a breach of licence condition and appropriate action would be taken. We left the premise at approximately 2.35pm

On Friday 17<sup>th</sup> February 2012 at 10.00pm, I attended the premise with PC Simpson to conduct a licensing check. The upstairs area was checked, barriers were in place and the CCTV was working. As we left the premise I spoke to a member of door staff and asked if they were using the search wand on customers entering the premises. I was informed that they were not. Advice given to ensure that the search wand was used as this was a condition on the licence. I then asked the doorman if they had been briefed by the DPS to use the search wand. I was informed that they had not been briefed on anything.

As of the 17<sup>th</sup> April 2012 I was informed by the Officer that Mr Hussain had provided a statement however, he didn't have the CCTV as he said he put it somewhere safe and can't remember where. He informed the officer that he may have taken it home and he said he would inform the officer. Mr Blake informed Mr Hussain that a noise abatement notice had already been issued to the premise, Mr Hussain was given full advice from Mr Blake and Mr Blake offered to assist him re the ongoing noise nuisance to the local residents. I then outlined Police concerns: No last entry time, drinks promotions being advertised £1.50 on shots, information being received of drugs in the premise, Alleged assault, evidence from the Enforcement Officer that the premises was being used after the licensable hours, premise being advertised as opening until 3am on You Tube and the capacity of 700. We spoke about the Temporary Events Notice until 5am next weekend, advice given to Mr Hussain that if there are any crime and disorder issues at this event, Thames Valley Police would object to any further TENS applications. I informed Mr Hussain that based on the evidence today the crime and disorder and public nuisance licensing objectives were being undermined and if the situation does not improve I will apply to review the premise licence.

Misleading applications for Temporary Events Notices

Section 19 issued on the opening night

Section 160 Order issued by a District Judge.

Police Sergeant Hewitt has stated that this is the worst premise he has ever been in, in over 15 years service. I am of the same view and can report that in over 10 years of working as the Police Licensing Officer and dealing with over 1,000 premises, I have never experienced such issues and lack of control within such a short time of opening. Let us not forget this premise only opened on Friday 3<sup>rd</sup> February 2012. This cannot continue as the public safety licensing objective and crime and disorder licensing objective are being undermined.

It is Thames Valley Police's view that due to the catalogue of incidents and non-compliance at

the premises and by the Designated Premises Supervisor the Premises Licence should be revoked. If however the members are of the opinion that the Premises Licence should not be revoked, Thames Valley Police request the premises licence is suspended and the below amendment and extra conditions are placed along side the existing licence:

All licensable activity to cease at midnight on all days of the week. The closing hours of the premises to be 00.30am of all days of the week.

Change of Designated Premises Supervisor

Designated Premises Supervisor to be on the premises during all licensable activity.

Thames Valley Police to be informed of all events with a minimum of 14 days notice to be given.

Last admission time to be 11.00pm.

Designated Premises Supervisor or Personal Licence Holder to be trained on how to work the CCTV System to the standard where the nominated person can download any potential evidence required by Thames Valley Police employees or relevant Agencies.

Suitably qualified First Aider with appropriate first aid supplies to be on duty during all licensable activities.

Polycarbonate glasses to be used.

Incident Register to be in place and kept up to date and made available upon the request of Thames Valley Police and any Authorised Officer of the Council and kept for a minimum of one year

All Staff members and SIA door staff to fully co-operate with Police Officers and make themselves available immediately upon the request of the Police Officer to give statements and provide CCTV.

Door staff Signing in and out Register to be in place and made available upon the request of Thames Valley Police and any Authorised Officer of the Council and kept for a minimum of one year.

Smokers to be limited to 10 persons at all times.

PC Simpson, Neighbourhood Specialist Officer, Slough Town Centre, and Sergeant Hewitt will be attending the hearing to support this review application.

At 1515 hours on Thursday16<sup>th</sup> February 2012 I attended RABZ nightclub with Sergeant Piper, Town Centre Sergeant, Rachael Rumney, Senior Licensing Officer, SBC – the visit was to check the CCTV system in relation to the breach of licence condition and the Section 19 notice being served on Mr Hussain, DPS on the 3<sup>rd</sup> February 2012 for breach of this condition.

Sergeant Piper checked the CCTV system, which had 6 working cameras. I noted and informed Sergeant Piper that not al the licensable area upstairs was covered by CCTV. We went to the upstairs area and Sergeant Piper then informed Mr Hussain that he was not satisfied with the CCTV coverage upstairs and at this stage was not going to issue a cancellation notice for the Section 19. Mr Hussain was fully updated by Sergeant Piper of our concerns with the upstairs area. He stated that the promoter only wanted to use the downstairs area. Sergeant Piper then stated that whilst the upstairs area was not being used, he would like an extra camera fitted and recording the stair area and if this was done, he would be satisfied with this. He also stated he would like physical barriers put in place at the top of the stairs to stop customers entering the upstairs area, which is not covered by CCTV. Mr Hussain agreed to do this. I then informed Mr Hussain that Thames Valley Police would return Friday afternoon (the next day) to ensure that the extra camera and barriers were in place and if this was done, a cancellation notice would be issued. Mr Hussain was also informed that if the extra camera was not in place Thames Valley Police would not serve a cancellation notice. Further advice also given re further breaches. Sergeant Piper also advised Mr Hussain of the trip hazard at the top of the stairs and advised him to rectify

We left the premises at 3.35pm.

As I was walking along the High Street I was handed a flyer advertising and promoting Rabz (see attached flyer).

I made the following observations on the flyer:

- 1. Capacity advertised as 700
- 2. Drinks promotions
- 3. VIP tables being advertised (No CCTV in the VIP area, I was previously informed by Mr Hussain this was upstairs)

On Friday 17<sup>th</sup> February 2012 at approximately 1.00pm I telephoned Mr Hussain to enquire if the camera had been installed – he confirmed that it had. I informed Mr Hussain that I would be attending the premise at approximately 2.00pm.

At 2.15pm on Friday 17<sup>th</sup> February 2012 I attended Rabz with PC 3000 Williams, Town Centre Officer and Rachael Rumney, Senior Licensing Officer, SBC. CCTV was checked and the extra camera had been installed.PC Williams then issued the Cancellation notice for the Section 19. I then informed Mr Hussain of my concerns over the flyer and what was being advertised. I reminded him that the capacity was 650 and not 700. Rachael

Rumney and I informed him of our concerns in relation to the cheap drinks being advertised. I also informed Mr Hussain that if there were any alcohol related crime and disorder issues at the premise we would have to become involved. Rachael informed him of the mandatory condition concerning drinks promotions.

I then informed Mr Hussain my initial concern re the advertising of the VIP tables, as I knew this area was upstairs and not currently covered by CCTV. Mr Hussain stated that the VIP area was now downstairs, I can confirm that the brown seating/sofas that were upstairs had been moved downstairs. I once again reminded Mr Hussain not to use the upstairs area until CCTV was covering the licensable area and if he did so this would be a breach of licence condition and appropriate action would be taken.



Dear Mr Magad Hussain (MH Properties Ltd)

As agreed in our meeting this morning I am sending this message to confirm our discussions.

As well as us Dan Lord of the Professional Sound Company was present and also my colleague Rhian Richards. I have also copied in all persons with an official interest.

The purpose of our meeting was to discuss the issue of noise nuisance to nearby residents created by the PA system in Rabz Nightclub at 305High Street Slough.

A notice was served in this regard and having been breached on 10/3/2012 was the subject of an earlier meeting between yourself and officers from Slough BC on 13/3/12.

During the meeting today we clarified that the notice still stands and **any breach** tomorrow, Saturday or at any time in the future will still be treated as **an offence** and we advised that should offences continue we would consider a seeking a **warrant** from the magistrates court to seize all noise making equipment.

You suggested the following interim measures to alleviate the noise after consultation with your adviser Dan;

- 1. All speakers on the first floor upper level to be disabled/turned off.
- 2. Speakers below the flat roofed area to the High Street side of the premises to be disabled /turned off including any near the entrance door.
- 3. The double door entrance/exit to be manned by security personnel who are to be advised to ensure that both sets of doors are to be closed when not in use. When people enter and leave an arrangement must be applied where only on set of doors is open at any one time the purpose of this is to prevent sound breakout.
- 4. The PA system to be turned "right down" to a level that you and Dan consider acceptable.

PLEASE NOTE The caveat for point 4 is as set out above ie the notice still stands and so any nuisance created may be treated as on offence for which you may be prosecuted and/or may assist in any representations we make to the court for a warrant to seize equipment.

In the long term you agreed that Dan Lord would provide details of acoustics' consultants who would prepare a schedule of attenuation (noise reducing works) to the premises which could include for example bricking up windows, roof sound insulation, noise limiting devices, reinforcing the front window and wood building face for example.

We will have officer patrolling Friday and Saturday and will advise you of their observations as to the improvements or otherwise that these measures achieve.

We suggest that once you have some firm outline proposals from your acoustic consultants that we meet again to discuss the proposals . In the meantime please respond and confirm that the measures 1 to 4 above will be carried out pending such works and that you understand that the notice still stands and any breach is an offence.

Thank you for your time today which was very much appreciated.

No seperate first aid room. On cctv staff had no external smoking area \_ and they were allowed to come and go at will with no searches and exit and re enter with what looks like alcohol in bottles.

### Other Information:

Upon arrival door staff at entrance did not have radio and no way of communicating with other SIA staff. He said he had given his radio to the girls at the bar as they were getting harassed by patrons. He was unable to identify the manager by name or location. He was unable to identify or contact the door supervisor. There was only one clicker and this was with the supervisor who was not on the door had to estimate the number of occupants. He was unable to call any other members of staff or direct me to injured persons. I was left with just having to go in and deal with what we found.

This is a shockingly bad establishment. SIA staff were inadequate in number to deal with even the smallest of incidents. Injured party was treating self in the kitchen area with tea towels and a dish rag.

They couldn't control the door/nightclub area. They did not appear to have a first aid room, any first aid kit i could see.

The sia door staff on the door did not have a radio. He was unable to direct me to injured persons or contact the SIA supervisor or licencee.

They couldn't even switch the lights on. They had no external smoking area and it can be seen from the cctv nobody is being searched as the enter/re enter and they are allowed to exit/re enter with bottles containing liquid.

This is the poorest pub i have been in in 15 years.

I write to express my on going concerns regarding premises at 308 High Street Slough, currently operating as "RABZ".

Since the opening, there have been various, repeated disturbances which do not allow me peaceful enjoyment of my property.

Reports have been made to the relevant bodies concerning episodes of disturbance which include (but are not limited to) street disorder, breach of noise regulations, public order offences, crimes against the person and I believe, breach of licensing obligations/conditions.

I find that the ongoing disruption are affecting me psychologically, emotionally, occupationally and financially.

My sleep duration is grossly reduced during the operational hours of the business. I work as front line Staff nurse for the NHS and am required to regularly work unsocial hours. Lack of sleep impairs my performance and potentially endangers the vulnerable adults that I work with.

I now experience an anxiety provoking stressful anticipation of disturbance from the premises which is distressing. There has been an occasion where noise from patrons in the street was sufficiently disturbing as to necessitate my leaving my property at 03.00hrs.

There have been concerns of violent and aggressive behaviour outside the club, including a potentially serious assault, which I cannot avoid witnessing.

I have had to excuse myself from work on at least one occasion owing to a very disturbed night. This causes financial damage to me personally and is problematic for my employer.

I have a diagnosed neurological condition known to be exacerbated by reduced sleep and it is of major concern that a relapse may be triggered as a result of these disturbances. I have already experienced a return of some symptoms which is indicative of reduced symptom control and decreased neurological stability

At times, I feel unsafe to leave my property as patrons tend to "spill out" into the street and, at times, the entrance to my property. Litter levels have increased and there have been incidences of vomit and urine in the entrance. This is a risk to my health and safety as well as being deeply distasteful and unpleasant. Traffic noise has also increased and the increased presence of emergency services gives the area a "no-go" feeling at times.

I would appreciate any assistance that you can give in the resolution of this situation.

Dear Sir/Madam,

My neighbour and myself are writing to make our objections to the licensing of the above club. We live at which is located 20 - 30 meters opposite the club. We are both key workers living at Key Worker Scheme Accommodation within

Also I am a Psychiatric Nurse within Acute Adult Inpatient Psychiatric Ward at local Hospital. my neighbour, is a teacher at a local primary school.

Since the opening of the club, on the 3rd of February 2012, we have been subjected to various, repeated disturbances, such as; increased traffic; noise from the bass within the club; shouting and screaming from customers inside and outside; street disorder i.e. littering/urinating/vomiting and violent behaviour. The violent behaviour in question have resulted in the request of the attendance of services of the police and ambulances on nearly regular basis. As a consequence of the continued disturbance, we have been unable to sleep. Furthermore, to counteract the increase noise and activity, we both had to flee from our premises, seeking shelter elsewhere. On one such occasion, where the noise from patrons in the street was sufficiently loud, I was forced to leave my property at 3.00am. I work as a front line Staff nurse for the NHS and am required to regularly work unsocial hours. Lack of sleep impairs my performance and potentially endangers the vulnerable adults that I work with. In addition I suffer from sleep deprivated Epilepsy which means that luck of sleep can cause relapse of my chronic illness and I could be potentially in danger from repeated seizures.

There have been concerns of violent and aggressive behaviour outside the club, including a potentially serious assault, which we both witnessed. The incident started with the club and then continued in the streets. My self and had to contact the police due to the violent nature of the crime. Unfortunately, this is not the only violent incident we have witnessed. On 7th May, we were both woken up by a fight outside the club, involving numerous girls.

At times, we feel unsafe to leave our properties as patrons tend to "spill out" into the street and to the entrance of our property. The risk to our health and safety as well as being deeply distressed and unpleasant nature of the club, have greatly increased.

Before the club opened we have been able to enjoy our properties; maintained good sleep patterns; fulfill our work duties and have a social life. Since the opening of the club all those areas of our lives have been greatly affected. If the club continues to trade, our life style will be severely affected, endangering those around us due to sleep deprivation we have experienced. The ongoing disruption had affected us psychologically, emotionally, occupationally and financially.

We hope that you would consider our concerns during the reviewing of the license.

Prevention of Public Nuisance	X	On the 20 <sup>th</sup> February 2012 a noise complaint was received by the Neighbourhood Enforcement Team from residents living on the opposite side of the road from the entrance to Rabz, 305 High Street Slough. The complaint was regarding noise in the form of loud amplified music, shouting and yelling coming from inside the club. The complaint also centred around activities in the street from the customers of Rabz. These activities included shouting, yelling, scream, fighting, loud music from customers cars, vomiting and drinking in the street.
		Evidence diaries were sent out to the complainants.
		On the 27 <sup>th</sup> February 2012 Out of Hours Officers on a pro-active noise visit went to the complainants opposite Rabz Night Club and witnessed base music coming from Rabz being

response was received.

On the 29<sup>th</sup> February 2012 based on the evidence provided to us by the complainants an Environmental Protection Act 1990 section 80 Noise Abatement Notice was served.

On the 11th March 2012 the Out of Hours Duty Officer was called out at 01:00 to attend the flats opposite Rabz due to the noise coming from the club. Between 02:15 and 03:07 the attending officer witnessed within the complainants flat noise in the form of amplified music and thumping base. Noise in the form of screaming, shouting and fighting in the street. At around 03:00 the club appeared to eject the last of its customers and a fight broke out in the street. At 03:15 the attending officer attended the club with two police officers and spoke to Majad Hussain who admitted he had received the Environmental Protection Act 1990 section 80 Noise Abatement Notice. Hussain went on to say that noise outside in the street and fighting was not his problem and that he had no understanding of noise management within the club. Majad Hussainsaid the club was licensed until 02:00 and had to be empty by 02:30.

On the 13<sup>th</sup> March 2012 a meeting was held at Windsor Police station with police, licensing, NET and Majad Hussain to discuss and resolve the incidents on the previous weekend. to discuss and resolve the incidents on the previous weekend.

On the 15<sup>th</sup> March 2012 NET officers visited Rabz and spoke with Majad Hussain regarding his noise management plans and how the club could be compliant with the Noise Abatement Notice.

On the 16<sup>th</sup> and 23<sup>rd</sup> March 2012 pro-active noise monitoring visits were made at 00:00 to 00:30. During these visits noise from amplified music within the club was minimal however noise was still witnessed in the street from Rabz customers.

Noise from Rabz in the form of loud amplified music complaints were then again received between the 27<sup>th</sup> April 2012 and 6<sup>th</sup> May 2012. Unfortunately due to technical difficulties within SBCs Careline service these complaints did not get referred to the Out of Hours Duty Officer so

- My name is Ian Blake I am employed by Slough Borough Council as the Neighbourhood Enforcement South Sector Team Leader.
- My duties with Slough Borough Council include managing a council team of Environmental Health Officers and Community Wardens using enforcement powers delegated to them to tackle Environmental Crime such as noise nuisance and anti social behaviour.
- On the 11<sup>th</sup> March 2012 I was the Out of Hours Duty Officer responding to noise complaints from the public. At 01:00 I received a phone call regarding a noise complaint from the councils Careline Service. I called the complainant and they advised me that they could not sleep due to noise from loud amplified music coming from a premises known as Rabz Nightclub, 305 High Street, Slough. I knew that Rabz Nightclub had an Environmental Protection Act 1990 section 80 Noise Abatement Notice in place so I agreed to visit that morning. I exhibit a copy of this Noise Abatement Notice as Exhibit IB1.
- I arrived at the complainants flat, which is located directly opposite Rabz Nightclub, 305 High Street Slough at 02:15. I had difficulty parking my car at a nearby location due to the number of other vehicles parked in that part of Slough High Street. As I walked to the communal entrance of the flats where the complainant lived I noticed a large gathering of people out side the entrance of Rabz Nightclub. I noticed that some of these people were drinking from bottles and that there was a lot of shouting and yelling in general. I estimate the number of people to be at least one hundred and I had difficulty walking on either side of the road due to the number of people in my way. I could see that a number were appearing to be intoxicated. I found the size of the groups and the atmosphere in the area in general intimidating.

- I entered the complainant's communal entrance and made my way up to their flat where I introduced myself and entered their home. There was also another complainant in this flat from a neighbouring flat who also said they could not sleep. I asked that all of the flat windows be closed so that I could listen. I noted that with all of the flat windows closed I could hear the thumping base beat from Rabz Nightclub. I could hear lyrics of a song being played but not clearly enough to make the lyrics out enough to either identify the words or the song. In addition to this I could clearly hear the shouting and yelling in the street outside. There was a constant noise from verbal conversation of individuals and groups in the street. This noise would then be punctuated by someone yelling at Rabz Nightclub door area or someone else in the street. These out bursts generally contained swear words or abusive language. The noise in total was at such a level it would prevent someone from sleeping or going about their business in their own home undisturbed.
- 6. Upon speaking with the complainants they told me that this activity had started at 22:00 and then at 00:00 it had got louder.
- 7. I then began to watch the activity in the street from the flat window which was directly opposite the entrance of Rabz Nightclub. I paid particular attention to the entrance of Rabz Nightclub. I noticed that at 02:30 people were still getting into the club and that these people we not individuals who had been previously smoking outside the club. At 02:40 a single person appeared to be ejected by door staff from the club and there was a loud abusive verbal confrontation at the club entrance. At 02:45 a scuffle appeared to take place around the club doorway with pushing and shoving and a lot of abusive shouting and yelling. Throughout all of these incidents there were at least one hundred people in the High Street area around Rabz Nightclub.
- 8. At 02:48 Rabz Nightclub appeared to be closing with people now coming out of the club in a constant stream into the High Street. At 03:00 about two hundred people had now gathered in an around the High Street area outside Rabz Nightclub. The road had become grid lock with people attempting to move their cars that were parked in the High Street directly outside the nightclub. In addition to cars attempting to move people from the club were walking and staggering into the road from the crowded pavement. An ambulance showing blue lights attempted to get through that part of the High Street and was caught up in the stationary traffic and general chaos causing it to be halted.
- 9. At 03:02 a fight broke out in the door way of Rabz Nightclub. A person dressed in a dark suit who appeared to be a member of Rabz Nightclub door staff came from inside the club and punched a person who was shouting at the entrance door area of Rabz Nightclub knocking them to the ground. At this point a group gathered around the entrance of Rabz Nightclub but nothing further appeared to occur. At 03:07 the Rabz Nightclub doors shut. This incident was captured on Council CCTV and I exhibit this CCTV footage as Exhibit IB2.
- 10. At 03:10 a number of police vehicles arrived and parked up. I then witnessed police officers attempting to get the traffic in the High Street moving and moving people gathered on the pavement and in the road on.

- 11. I then left the complainants flat and went out into the street. I noticed a number of police officers gathered by the side of a police van. I introduced myself showing my authorisation and asked if one of them would accompany me whilst I attempted to speak with the staff of Rabz Nightclub. Two officers then came with me to Rabz Nightclub.
- 12. At 03:15 I knocked on the door of Rabz Nightclub. Upon the door being answered I introduced myself and asked to speak with the manager. I and the two police officers were invited inside of the nightclub and introduced to a person who identified himself as the person in charge and that his name was Majad Hussain of
- 13. I introduced myself to Majad Hussain showing my authorisation and I explained to him why I was asking to see him and I explained what I had witnessed since 02:15.
- 14. Majad Hussain said he had received the Environmental Protection Act 1990 section 80 Noise Abatement Notice however he did not understand what it meant and that he thought he had 28 days to comply as opposed to appeal. Majad Hussain said that the sound system was build into the club by CVA Sound and that they had set the limits. When I asked Majad Hussain what were the limits and did he have a Noise Management Plan he replied he did not know. I asked Majad Hussain if the club had a noise limiter and he said yes. I then asked Majad Hussain what the limit was set at and again he replied he did not know.
- 15. I asked Majad Hussain about his opening times and he told me that the club allowed people in until 02:00 and then had to empty by 02:30 as per Rabz Nightclub licensing conditions. I then said that people were still entering Rabz Nightclub at 02:30 and that closure of the club appeared to be at 03:00. Majad Hussain replied by stating that the club has closed at 02:30 that morning and I had been mistaken.
- 16. I asked Majad Hussain about how the club dealt with noise from customers in the street and any fights that broke out on the doors of the club or in the street. Majad Hussain replied that it was not his problem and how could he control what was going on outside and that he was not interested in any fight or rowdiness in the street.
- 17. I and the two other police officers left Rabz Nightclub at 03:30. Upon entering the High Street it was empty of people and cars.
- 18. I am available to act as a formal witness if required.

**TAKE NOTICE** that under the provisions of the Environmental Protection Act 1990 the Slough Borough Council ("the Council"), being satisfied of the likely occurrence of noise amounting to a statutory nuisance under section 79(1)(g) of that Act at:

within the district of the said Council arising from: noise from loud amplified music and /or associated bass, noise associated with the internal announcement system and noise from customers inside the property.

**HEREBY REQUIRE YOU**, as the company responsible for the said nuisance and occupier of the premises from which the noise would be emitted immediately from the service of this notice to abate the occurrence of the same and for that purpose require you to:

Ensure that noise from loud amplified music and /or associated bass, noise associated with the internal announcement system and noise from customers inside the property does not cause a nuisance to nearby residents.

**THIS** is a notice to which paragraph (2) of regulation 3 of the Statutory Nuisance (Appeals) Regulations 1995 applies and, in consequence, in the event of an appeal this notice shall NOT be suspended until the appeal has been abandoned or decided by the Court, as, in the opinion of the Council, the nuisance to which this notice relates is likely to be of a limited duration such that suspension would render the notice of no practical effect.

IF without reasonable excuse you contravene or fail to comply with any requirement of this notice you will be guilty of an offence under section 80(4) of the Environmental Protection Act 1990 and on summary conviction will be liable to a fine not exceeding level 5 on the Standard Scale\*\*, together with a further fine of an amount equal to one-tenth of that level for each day on which the offence continues after conviction. A person who commits an offence on industrial, trade or business premises will be liable on summary conviction to a fine not exceeding £20,000.

The Council may also take proceedings in the High Court for securing the abatement, prohibition or restriction of the nuisance. Further, if you fail to execute all of any or the works in accordance with this notice, the Council may execute the works and recover from you the necessary expenditure incurred.

    - that there has been some informality, defect or error in, or in connection with, the abatement notice, or in, or in connection with, any copy of the abatement notice served under section 80A(3) (certain notices in respect of vehicles, machinery or equipment); (b)
    - that the authority have refused unreasonably to accept compliance with alternative requirements, or that the requirements of the abatement notice are (c) otherwise unreasonable in character or extent, or are unnecessary;
    - that the time, or, where mote than one time is specified, any of the times, within which the requirements of the abatement notice are to be complied (d) with is not reasonably sufficient for the purpose;
    - where the nuisance to which the notice relates (e)
      - is a nuisance falling within section 79(1)(a), (d), (e), (f) or (g) of the 1990 Act and arises on industrial, trade or business premises, or
      - is a nuisance falling within section 79(1)(b), of the 1990 Act and the smoke is emitted from a chimney, or
      - is a nuisance falling within section 79(1)(ga) of the 1990 Act and is noise emitted from or caused by a vehicle, machinery or equipment being (iii) used for industrial, trade or business purposes,

that the best practicable means were used to prevent, or to counteract the effect of, the nuisance;

- that, in the case of a nuisance under section 79(1)(g) or (ga) of the 1990 Act (noise emitted from the premises), the requirements impose by the (f) abatement notice by virtue of section 80(1)(a) of the Act are more onerous than the requirements for the time being in force, in relation to the noise to which the notice relates, of
  - any notice served under section 60 or 66 of the Control of Pollution Act 1974 ("the 1974 Act", (control of noise on construction sites and from certain premises), or
  - any consent given under section 61 or 65 of the 1974 Act (consent for work on construction sites and consent for noise to exceed registered level in a noise abatement zone). or

any determination made under section 67 of the 1974 Act (noise control of new buildings);

- that, in the case of a nuisance under section 79(1)(ga) of the 1990 Act (noise emitted from or caused by vehicles, machinery or equipment), the requirements imposed by the abatement notice by virtue of section 80(1)(a) of the Act are more onerous than the requirements for the time being in force, in relation to the noise to which the notice relates, of any condition of a consent given under paragraph 1 of Schedule to the Noise and Statutory Nuisance Act 1993 (loudspeakers in streets or roads);
- that the abatement notice should have been served on some person instead of the appellant, being -(h)

the person responsible for the nuisance, or

the person responsible for the vehicle, machinery or equipment, or

in the case of a nuisance arising from any defect of a structural character, the owner of the premises, or (iii)

- in the case where the person responsible for the nuisance cannot be found or the nuisance has not yet occurred, the owner or occupier of the (iv) premises:
- that the abatement notice might lawfully have been served on some person instead of the appellant, being -(i)
  - in the case where the appellant is the owner of the premises, the occupier of the premises; or
  - in the case where the appellant is the occupier of the premises, the owner of the premises,

and that it would have been equitable for it to have been so served;

- that the abatement notice might lawfully have been served on some person in addition to the appellant, being -(j)
  - a person also responsible for the nuisance, or (i)
  - a person who is also owner of the premises, or
  - a person who is also an occupier of the premises or, (iii)
  - a person who is also the person responsible for the vehicle, machinery or equipment, (iv)

and that it would have been equitable for it to have been so served.

- if and so far as an appeal is based on the ground of some informality, defect or error in, or in connection with, the abatement notice, or in, or in connection (3) with, any copy of the notice served under section 80A(3), the court shall dismiss the appeal if it is satisfied that the informality, defect or error was not a material one.
- Where the grounds upon which an appeal is brought include a ground specified in paragraph (2)(i) or (j) above, the appellant shall serve a copy of his notice (4) of appeal on any other person referred to, and in the case of any appeal to which this regulation applies he may serve a copy of his notice of appeal on any other person having an estate or interest in the premises, vehicle, machinery or equipment in question.

On the hearing of the appeal the court may (5)

- quash the abatement notice to which the appeal relates, or
- vary the abatement notice in favour of the appellant, in such manner as it thinks fit, or

dismiss the appeal; (c)

and an abatement notice that is varied under sub-paragraph (b) above shall be final and shall otherwise have effect, as so varied, as if it had been so made by the local authority

Subject to paragraph (7) below, on the hearing of an appeal the court may make such order as it thinks fit -(6)

- with respect to the person by whom any work is to be executed and the contribution to be made by any person towards the cost of the work, or
- as to the proportions in which any expenses which may become recoverable by the authority under Part III of the 1990 Act are to be borne by the appellant and by any other person,

In exercising its powers under paragraph (6) above, the court -(7)

- shall have regard, as between an owner and an occupier, to the terms and conditions, whether contractual or statutory, of any relevant tenancy and to (a) the nature of the works required, and
- shall be satisfied, before it imposes any requirement thereunder on any person other than the appellant, that that person has received a copy of the notice of appeal in pursuance of paragraph (4) above.
