The use of flash photography, additional lighting or any non hand held devices, including tripods, will not be allowed unless this has been discussed with the Democratic Services Officer.



PREDETERMINATION/PREDISPOSITION - GUIDANCE

The Council often has to make controversial decisions that affect people adversely and this can place individual members in a difficult position. They are expected to represent the interests of their constituents and political party and have strong views but it is also a well established legal principle that members who make these decisions must not be biased nor must they have pre-determined the outcome of the decision. This is especially so in "quasi judicial" decisions in planning and licensing committees. This Note seeks to provide guidance on what is legally permissible and when members may participate in decisions. It should be read alongside the Code of Conduct.

Predisposition

Predisposition is lawful. Members may have strong views on a proposed decision, and may have expressed those views in public, and still participate in a decision. This will include political views and manifesto commitments. The key issue is that the member ensures that their predisposition does not prevent them from consideration of all the other factors that are relevant to a decision, such as committee reports, supporting documents and the views of objectors. In other words, the member retains an "open mind".

Section 25 of the Localism Act 2011 confirms this position by providing that a decision will not be unlawful because of an allegation of bias or pre-determination "just because" a member has done anything that would indicate what view they may take in relation to a matter relevant to a decision. However, if a member has done something more than indicate a view on a decision, this may be unlawful bias or predetermination so it is important that advice is sought where this may be the case.

Pre-determination / Bias

Pre-determination and bias are unlawful and can make a decision unlawful. Predetermination means having a "closed mind". In other words, a member has made his/her mind up on a decision before considering or hearing all the relevant evidence. Bias can also arise from a member's relationships or interests, as well as their state of mind. The Code of Conduct's requirement to declare interests and withdraw from meetings prevents most obvious forms of bias, e.g. not deciding your own planning application. However, members may also consider that a "non-pecuniary interest" under the Code also gives rise to a risk of what is called apparent bias. The legal test is: "whether the fair-minded and informed observer, having considered the facts, would conclude that there was a real possibility that the Committee was biased'. A fair minded observer takes an objective and balanced view of the situation but Members who think that they have a relationship or interest that may raise a possibility of bias, should seek advice.

This is a complex area and this note should be read as general guidance only. Members who need advice on individual decisions, should contact the Monitoring Officer.

11. Private Hire Driver Conduct Hearing- (Reference 02-16)

The Following is a Part 1 summary of the case:

The Licensing Sub-Committee was asked to consider whether Private Hire Driver (Reference 02-16) was a fit and proper person to continue to hold a Private Hire licence in Slough.

The Licensing Officer summarised the background to the case and discussed the relevant Policy and Legislative considerations. She advised Members that the Sub-Committee could only allow an Applicant to hold a Licence if it was satisfied that the applicant was a 'fit and proper' person to do so.

In February, 2016, the Licensing Team received official notification that the Driver (whilst working as a Private Hire Taxi Driver), was arrested by Thames Valley Police for using threatening, abusive, insulting words or behaviour with

intent to cause fear of/provoke unlawful violence, and that he accepted a Fixed Penalty Notice ("FPN").

The Driver addressed the Sub-Committee, and presented evidence in mitigation.

The Sub-Committee carefully considered all the evidence at its disposal, and concluded that the Driver was not fit and proper to continue to hold a Private Hire Drivers Licence.

Resolved- That the Private Hire Driver's (ref 02-16) Licence be revoked.

1. Recommendations

- 1.1 That Licensing Sub Committee determine the Application.
- 1.2 The Sub Committee may:
 - (a) Grant the Application subject to Conditions, variations, or restrictions the Council thinks reasonably necessary; or
 - (b) Refuse the Application.

2. Principles for making decisions

2.1 Context

- 2.1.1 As a quasi-judicial body the Sub Committee is required to consider the application on its merits and must act reasonably and rationally. The Sub Committee can only take into account relevant factors and must ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of the relevant facts, or the likelihood or the unlikehood of some future event, the occurrence of which would be relevant. The Sub Committee must give fair consideration to the contentions of all persons entitled to make representation to them.
- 2.1.2 The Sub Committee can only consider matters within the application that have been raised through representations.
- 2.1.3 Members should note that the Sub Committee is meeting on this occasion solely to perform the role of licensing authority. As such Members should disregard the Council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the Council's related policies and guidance.

2.1.4 Members will be aware of the Council's Code of Conduct which requires them to declare interests. The Code applies to Members when considering licensing applications. In addition as a quasi-judicial body, Members are required to avoid both actual bias and the appearance of bias.

2.2 Human Rights & Equality Act Duties

- 2.2.1 In determining the application the Sub Committee should be aware of and take into account any implications that may arise from the Human Rights Act 1998 and S149 Equality Act 2010. The Act makes it unlawful for a public authority to act in a manner which is incompatible with the European Convention of Human Rights.
- 2.2.2 When determining the application and considering imposition of conditions the Sub Committee must be satisfied that any decision which interferes with the rights of the applicant or of others only does so insofar as it is necessary to protect the rights of others and that no alternative decisions would be appropriate.
- 2.2.3 The Sub Committee is specifically referred to the following Convention rights:
 - (a) Article 6 (the right to a fair trial);
 - (b) Article 8 (the right to respect for private and family life); and
 - (c) Article 1 of the First Protocol (the protection of property).

3. Application Summary

3.1 Application for: Street Trading Consent.

3.2 Applicant: Mr Mohsin A Kayani

3.3 Name of Business: "Mean Burger"

3.4 Proposed business: Sale of fast food, consisting of 'gourmet' beef, chicken burgers and 'home made' chips

3.5 Site location: The service on Farnham Road between 220 ("Farnham Road Post Office") and 216-218 ("Way to Save").

3.6 Hours of operation: Monday to Saturday: 19:00 – 23:00 and

Sunday: 17:00 - 23:00.

3.7 Consent duration: Annual

3.8 Operating history: The Applicant is not trading at present.

3.9 Trading vehicle: The trailer to be used for the business is white, 10'x6'6"x6'6" and will be towed by an off-road vehicle.

3.10 Site history A Street Trading Consent for the site has previously been granted and an individual had been trading from 2006 until October 2015

3.11 Objections A number of local residents have objected to the current application.

4. Background

- 4.1 On 24 November 1987, Slough Borough Council adopted street trading powers under section 3 and Schedule 4 of Local Government (Miscellaneous Provisions) Act 1982. The Council has designated all streets in their Borough as consent streets. Street trading is only allowed in consent streets with the consent of the Council. The Council may limit the number of consents issued and may attach appropriate conditions to consents.
- 4.2 An individual wishing to offer goods or services for sale, from a fixed stall or location on the public highway, must have a Street Trading Consent issued by the local authority.
- 4.3 The Applicant has submitted an application for a Street Trading Consent as detailed in Section 3 and produced as **Appendix A**
- 4.4 The site is located on the map at **Appendix B**, a photograph of the site for which the Applicant seeks the consent is attached at **Appendix C** and 2 satellite views of the location of the site are attached at **Appendix D**.
- 4.4 A Street Trading Consent for this site was previously granted to "Aleks Kebabs" who operated on this site from at least 2009 to November 2015 until he ceased trading due to ill health. No complaints were received about the operation on Aleks Kebabs. The Applicant's proposed user is very similar Aleks Kebabs.

5. Policy Considerations

- (k) Owners or occupiers of any property within 100 metres of the proposed site. This consultation will be by way of sending a copy of the Notice of Application to the relevant property owners
- 6.2 Owners or occupiers of any property within 100 metres of the proposed site have been consulted by way of a Notice of Application
- 6.3 A copy of the Council's letter is attached at **Appendix E.** Following the consultation exercise; the Council has received a number of objections. Copies of the objections are attached at **Appendix F**.
- 6.4 In summary the objections raise the following matters:
 - (a) The granting of this application would result in noise and anti-social activities.
 - (b) Increase in litter in the form of food waste and drinks cans and bottles.
 - (c) Loss of view to current shop holders if the Consent is granted.
 - (d) Obstruct access onto the service road.

7. Conditions

- 7.1 The Council has a set of Standard Terms & Conditions which apply to any Street Trading Consent.
- 7.2 The Council may also attach such other conditions it considers reasonably necessary.
- 7.3 The Council may at any time vary the conditions of a Consent.
- 7.4 The Council may revoke a Consent at any time.
- 7.5 The Consent is valid for a year and can be reviewed annually.
- 7.6 The holder of a Consent may at any time surrender his Consent to the Council and it shall then cease to be valid.

8. Recommendation

If the Sub Committee are minded to grant the application, it is recommended that the following conditions are imposed on the Consent in addition to the "Street Trading Consents Standard Terms and Conditions" to deal with the objections and concerns raised by nearby residents:

- 8.1 A limit on the hours of trade which can be undertaken by the Applicant,
- 8.2 A bin must be placed on the site and a litter pick of a 25 metre radius of the site undertaken by the Applicant on a daily basis.
- 8.3 The Applicant to remove all rubbish daily.
- 8.4 A prohibition on leaving vehicles at the site overnight.

The Licensing Team can review any further complaints received during the Applicant's first year of trade.





Slough Borough Council is responsible for the licensing of Street Trading Consents in accordance with Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982.

Where new applications for Street Trading Consents are made, in line with Council policy, it is necessary to consult formally with relevant parties and local residents and or businesses in the vicinity of the proposed area where the trading has been requested to take place.

On July 25th 2016, an application was made for a Street Trading Consent for trading to take place in the service road off Farnham Road, between Farnham Road Post Office and Way to Save, (please see attached map).

The type of trading to be carried out is the sale of hot food, Monday to Saturday between the hours of 19:00 and 23:00, and Sunday 17:00 and 23:00.

Where the proposed trading to take place is to be defined as 'Late Night Refreshment' i.e. hot food and drink between the hours of 11.00 pm and 05.00 am, an application will also have to be made for a Premises Licence under the Licensing Act 2003, which will be subject to a separate statutory consultation.

I would therefore be grateful if you could forward any objections or representations you may have to the application to — **The Licensing Team, Landmark Place, High Street, Slough, SL1 1JL** or by email to licensing@slough.gov.uk, no later than 20 days from the date of this letter quoting the address of the proposed trading site.

If objections or representations are received to the application the matter will be referred to a Licensing Sub Committee for determination with a hearing to take place normally between 4 to 8 weeks from the date of the application being made.

The Licensing Sub Committee is made up of local Councillors who will determine each application on its own individual merits. At the Committee hearing the applicant(s) and objectors will be given the opportunity to put their case forward. The Committee are empowered to grant, refuse or apply any relevant conditions in addition to the **General Conditions** to any licence application put before them.


Dear Mick,

Dear Mr. Sims,

I am writing to voice my objection to the proposed Street Trader licensing in the servicing road off Farnham Road (address shown in heading),

I with my family for the past 30yrs and the closest living resident As a resident at to the potential trading site, I have witnessed, first hand, the inconvenience a street trader on this site proposes. Please see my objections below:

1) Litter - The litter in the car park on the service road and the surrounding streets became absolutely terrible whilst the previous street trader was there. The litter, discarded food and drink cans from the kebab van compiled with the litter from other fast food outlets in the immediate vicinity was horendous.

The combination of the previous street trader along with Peri Peri Chicken (246 Farnham Rd), Chicken Delight (238 Farnham Rd), Tops Pizza (222 Farnham Rd), KFC (Edinburgh Ave) has culminated in huge amounts of litter in the car park which eventually gets blown into our front gardens and street. This attracts rats from the small rest park opposite and from behind the shops, where refuge is often over flowing from bins.

- 2) Antisocial behaviour Over the last few years we have had a continual problem with groups of people with modified cars driving dangerously and loudly in the area. The previous street trader acted as a hub and meeting point for these groups of people along with the adjoining car park, where they would consume food and hot bevearges whilst demonstrating their vehicles. The problem has now extended to the car park of KFC (Edinburgh Ave). The continual revving of modified engines, loud exhausts, wheelspins and sound systems has become quite unbearable in both the the KFC and service road car parks. I am sure a briefing with the police will confirm this issue.
- 3) Noise The continual noise of the street trader van generator is a particular nuisance. I can only imagine its far worse for the residents living in the residence above the Farnham road Post Office and Way to Save where the proposed site is situated.
- 4) Smell the residents of Sheffield Road and the surrounding streets have had to endure the continual smell of the vast number of fast food outlents around the service road. The street trader contributes considerably to this.

- 5) Access on the service road Under the previous trader, it became a regular event to see the kebab van pull into the service road and block all access through whilst he waited for the owners of parked cars in his trading spot to arrive and move their vehicles. This would result in a lot of frustration for drivers that would not be able to use the service road whilst the street trader waited to park his kebab van. I have been witness to quite a few road rage incidents due to this.
- 6) General saftey on service road Over the last few years I have seen the service road and its car park used more and more dangerously. The one way traffic and No Entry sign are continually ignored by the vast majority with no obvious pedestrian walk through. The previous kebab van contributed to the danger by resticting peoples views as they drive around the bend of the service road and also with customers parking on pavements and generally causing congestion whilst they eat in their cars.

I sincerely hope that you will consider the points I have made above and deny the license for the Street Trader License and a potential 'Late Night Refreshment' license. Since the last trader has ceased to operate, we have had a respite from the all the problems highlighted above. I please ask you not to make us to endure it all over again. The highlighted problems have escalated continually as Farnham road and the area changes. Re-issuing a street license will only compound these growing concerns.




