80. Declarations of Interest

None were declared.

81. Minutes of the Last Meeting held on 15th March 2018

Resolved – That the minutes of the meeting held on 15th March 2018 be approved as a correct record.

82. Action Progress Report

Details on the current status of actions agreed were outlined for Members consideration.

Resolved – That details of the Action Progress Report be noted.

84. Five Year Plan - Outcome 5 Update

The Committee considered a report that updated on the progress being made in delivering against Outcome 5 of the Council's Five Year Plan: 'Slough will attract, retain and grow businesses and investment to provide jobs and opportunities for our residents.' The update was focused on key actions 1, 3, 5 and 6 relating to promoting inward investment, skills, the town centre and opportunities from Heathrow expansion. The Outcome included a wide range of activities across Council departments and the role of the newly established Regeneration Directorate was noted.

(Councillor Sarfraz joined the meeting)

Members had a detailed discussion about the work the Council was doing to maximise the opportunities for Slough arising from the expansion of Heathrow airport, and the steps being taken to mitigate some of the negative impacts. The Director of Regeneration commented that the Cabinet had recently agreed the Council's response to a consultation Heathrow was conducting

and that had emphasised the importance of retaining a 'green envelope' around Colnbrook and ensuring the road and rail links to the airport were improved. The Council was working proactively through the Heathrow Strategic Planning Group to try to secure the best possible package of measures for Slough and was also working with partners on skills and employability issues to help local residents access job opportunities. A Member asked whether the Council's public support for expansion had reduced its influence in securing the best deal. In response, it was noted that a range of specific local benefits had been secured through a Memorandum of Understand between the Council and Heathrow airport, which was being reviewed again to secure the best possible package. The Committee was assured that the Council was being ambitious in its 'asks' of Heathrow and was also working to maximise the wider investment and employment opportunities that an expanded airport would provide.

The Committee discussed the measures being taken to increase the vibrancy of the town centre following the concerns raised by Members about the loss of several key retailers in recent years. The redevelopment of the former Thames Valley University site and major investment plans of Catalyst Capital was part of the long term regeneration of the town centre and the Council was also taking more immediate measures such as the proposal for a Business Improvement District and a programme of events to attract people into the town centre. Members emphasised the importance of having a clear plan and timescales to coordinate this interim activity and it was noted that the Town Centre Partnership was leading this plan.

In view of the major investment and economic development likely to take place in and around Slough in the coming years, the Committee agreed the importance of ensuring that the Council and partners had the investment, training and skills programme in place so that local people could benefit. It was agreed that the Committee would receive a report on how the investment and skills opportunities could be secured in the new municipal year after the expected House of Commons vote on Heathrow expansion.

At the conclusion of the discussion, the report was noted.

Resolved -

- (a) That details of the report be noted.
- (b) That the Committee receive a report on the detailed plans to maximise the skills and investment opportunities arising from Heathrow expansion and other major economic development schemes at a future meeting.

85. Votes at 16

The Committee discussed a report on the current national proposals to reduce the age of the national franchise to sixteen. The devolved administrations in Scotland and Wales had or would consider lowering the voting age for some

electoral events and this had reopened a similar debate in England. It was noted that the Council had passed a motion on 21st April 2015 that supported the principle of votes for 16 and 17 year olds.

Councillors Strutton, Pantelic and Sadiq addressed the Committee under Rule 30 and Members had a wide ranging discussion during which a number of different points of view were expressed. The was strong support from most Members for a reduction to the voting age in principle, however, some Members also felt the changes should be part of a wider package of reform which included the use of voter identification and measures to improve engagement in the democratic process. The excellent work of the Slough Youth Parliament was highlighted and Members specifically noted the very high levels of turnout in their elections which was evidence of a high level of engagement and interest of young people. It was recognised that the voting age could only be lowered if there was a change in legislation and it was noted that there were campaigns to this end and a Private Member's Bill currently in the House of Commons.

At the conclusion of the discussion, the Committee agreed to make a recommendation that full Council debate the matter on 24th April 2018. The Committee would recommend that the principle of lowering the national voting age be supported with the Council taking a proactive role in supporting appropriate campaigns on this matter. It was also proposed and agreed that a scrutiny task and finish group be established to take forward the practical measures associated and that this would also examine and make proposals on the practical steps that could be taken to increase the security of the electoral process, which would potentially include the use of voter identification at polling stations. The task and finish group would also be asked to consider what could be done to promote youth participation in any campaign, local consultation and/or the democratic process more widely if the voting age was lowered.

Recommended – That the Council resolve to support the principle of reducing the national voting age to 16; take an active leadership role in any appropriate campaign(s) to further this objective; and request scrutiny to establish a task and finish group to examine and propose practical measures to improve the security of the ballot, including potentially voter identification, and promote youth participation.

86. **Annual Scrutiny Report 2017/18**

The Scrutiny Officer outlined details of the Annual Scrutiny Report 2017/18 for Members consideration. The annual report included a review of the scrutiny work programme for the past year and assessed the impact scrutiny had had on influencing policy and holding the Executive to account. In particular, the work the Committee and panels had done to scrutinise the Council's Five Year Plan and the ongoing review of a range of housing issues were noted.

The Chair thanked the Vice-Chair of the Committee and all Chairs and Vice-Chairs of the panels for their support and leadership throughout the year. Officers were also thanked for their contributions to the Overview and Scrutiny function. At the conclusion of the discussion it was agreed to request that full Council endorse the Annual Scrutiny Report at its meeting on 24th April 2018.

3.1 The Council's decision-making and the effective scrutiny of it underpins the delivery of all the Joint Slough Wellbeing Strategy priorities. The Overview and Scrutiny Committee (OSC), alongside the 3 Scrutiny Panels combine to meet the local authority's statutory requirement to provide public transparency and accountability, ensuring the best outcomes for the residents of Slough.

5. Supporting Information

Initial Discussion Regarding a Possible Task & Finish Group

- 5.1 At its meeting on 12th April 2018, OSC took an item on lowering the voting age to 16. During the subsequent discussion, OSC recommended that Council should support a change in the voting age (as specified in the agenda paper's proposed recommendations). This recommendation was then taken to Council at its meeting on 24th April 2018.
- 5.2 In addition to this, OSC also discussed other matters relating to public participation and voting. Firstly, members asked that Council be asked to consider how it could support efforts to alter the electoral franchise, and more widely how young people could be encouraged to take an active role in public life. In addition, the issue of the security of the ballot was raised. As a result, both of these matters were also taken to Council on 24th April 2018.

5.3 Given the above discussions, the following recommendation was made to Council:

The Committee recommends that the Council resolve to support the principle of reducing the national voting age to 16; take an active leadership role in any

appropriate campaign(s) to further this objective; and requests scrutiny to establish a task and finish group to examine and propose practical measures to improve the security of the ballot, including potentially voter identification, and promote youth participation.

5.4 This recommendation was put to the vote and carried unanimously. As a result, OSC is now being asked to decide whether to commission this Task and Finish Group.

Potential Next Steps

- 5.5 Should the Task and Finish Group be commissioned, the next phase of the procedure would be:
 - a) Scrutiny Officer to request nominations for membership of the Task and Finish Group (these individuals need not be confined to members of OSC);
 - b) Meeting to be held with Task and Finish Group to draft terms of reference for the review;
 - c) OSC to be asked to approve, amend or reject these terms of reference (either electronically or at its next meeting); and
 - d) Once terms of reference agreed, Task and Finish Group to undertake its review. Once this is completed, it will then report back to OSC with its final report and any recommendations arising.

7. Conclusion

OSC is requested to make a decision as to whether to commission the Task & Finish Group outlined in the previous sections of this report.

- 3.1 The Council's decision-making and the effective scrutiny of it underpins the delivery of all the Joint Slough Wellbeing Strategy priorities. The OSC, alongside the 3 Scrutiny Panels combine to meet the local authority's statutory requirement to provide public transparency and accountability, ensuring the best outcomes for the residents of Slough.
- 3.2 The work of scrutiny also reflects the priorities of the Five Year Plan, as follows:
 - Slough children will grow up to be happy, healthy and successful
 - Our people will be healthier and manage their own care needs
 - Slough will be an attractive place where people choose to live, work and stay
 - Our residents will live in good quality homes
 - Slough will attract, retain and grow businesses and investment to provide opportunities for our residents

3.3 Overview and Scrutiny is a process by which decision-makers are accountable to local people, via their elected representatives for improving outcomes relating to all priorities for the Borough and its residents. Scrutiny seeks to influence those who make decisions by considering the major issues affecting the Borough and making recommendations about how services can be improved.

4. Supporting Information

- 4.1 The purpose of Overview and Scrutiny is to hold those that make decisions to account and help Slough's residents by suggesting improvements that the Council or its partners could make.
- 4.2 Prioritising issues is difficult. The Scrutiny function has limited support resources, and therefore it is important that the work scrutiny chooses to do adds value.
- 4.3 There are three key elements that make up the responsibilities of the Overview and Scrutiny Committee:
 - provide transparency and public accountability for key documents relating to the financial management and performance of the Council;
 - scrutinise significant proposals which are scheduled for, or have been taken as, a Cabinet/Officer delegated decision; and
 - strategic shaping of service improvements relating to the Cabinet Portfolios of Finance & Strategy and Performance & Accountability
- 4.4 In considering what the OSC should look at under points two and three above, Members are invited to consider the following questions:
 - To what extent does this issue impact on the lives of Slough's residents?
 - Is this issue strategic and pertinent across the Borough?
 - What difference will it make if O&S looks at this issue?

5. Suggested Topics

- 5.1 It is generally recommended that a Scrutiny Committee should aim to look at no more than 3 or 4 items in any one meeting. This limited number can prove challenging, but does allow the Committee to delve down into specific subject areas and fully scrutinise the work that is being undertaken.
- 5.2 This will be a continuous process, and flexibility and responsiveness vital to success. It is important not to over-pack the Committee's agenda at the start of the year, which will not allow the flexibility for the Committee to adapt to take into consideration issues that have arisen during the year.

6. Resource Implications

Overview and Scrutiny is supported by 1 FTE member of staff. This officer is responsible for support the O&S Committee and three Scrutiny Panels. Therefore, this is a finite resource and consideration must be given, in conjunction with the work programmes for the three Scrutiny Panels, as to how the resource is used during the year.

7. Conclusion

- 7.1 The Overview and Scrutiny Committee plays a key role in ensuring the transparency and accountability of the Council's financial and performance management, and strategic direction. The proposals contained within this report highlight some of the key elements which the Committee must or may wish to scrutinise over the coming municipal year.
- 7.2 This report is intended to provide the Committee with information and guidance on how best to organise its work programme for the 2018/19 municipal year. As previously stated, this is an ongoing process and there will be flexibility to amend the programme as the year progresses, however, it is important that the Committee organises its priorities at the start of the year.
