Standing Advisory Council on Religious Education – Meeting held on Wednesday, 4th March, 2020

WELCOME

The Chair welcomed Religious Education (RE) leads, co-ordinators and teachers who were present as observers to the meeting.

12. Minutes of the Last Meeting held on 6 November 2019

Resolved - The minutes of the previous meeting held on 6 November 20219 were approved as a correct record.

(With the agreement of the SACRE, the Chair altered the order of the agenda.)

13. Matters Arising

Christine Isles advised that the date for the Pan-Berkshire SACRE Hub summer conference had been arranged for Wednesday 22 July 2020.

Resolved – That the date of the Pan-Berkshire SACRE Hub summer conference be noted as Wednesday 22 July 2020.

14. SACRE Membership Update

The Clerk advised that Gulzari Lal Babber had stepped down from the Hindu Cultural Society, Slough Hindu Temple and would no longer be the Hinduism representative on SACRE.

It was reported that Rev Andrew Allen, Church of England representative would be attending SACRE meeting for the last time following his retirement and pending move from Slough to pastures new.

On behalf of SACRE, the Chair thanked Rev Allen and Gulzari Lal Babber for their time and valuable contributions made to SACRE. Rev Allen was also commended for his commitment to SACRE.

Councillor (Cllr) Brooker advised that he would be taking up the mayoral role in the next municipal year. Cllr Brooker also reported that he was the vicechair of the governing body at Ryvers Primary School.

Members discussed the long standing issue of the high level of vacancies in the category identified as Committee 3; to replace the current named unions with six teachers and teachers' representatives and highlighted that many of the bodies in that category were out of date. As part of the campaign to promote greater awareness of the work of SACRE in schools, members were encouraged to note that a number of primary and secondary teachers had expressed an interest in joining SACRE and were pleased to see those present at the meeting as observers.

Members proposed that the SACRE terms of reference be reviewed to amend Committee 3 category; to replace the current named unions with six teachers and teacher representatives from any union in primary and secondary (including special schools) schools in Slough. The SACRE instructed work to be undertaken to review its membership and terms of reference and for this to be undertaken in liaison with the Chair/Vice-Chair, local authority officers and the SACRE adviser. The decision-making process would require a report to be produced and agreed at a SACRE meeting and reported to the Member Panel on the Constitution, followed by ratification at a Council meeting.

Resolved:

- i) That the updates be noted.
- ii) That a review of the SACRE Terms of Reference be amend to replace the current named unions in Committee 3 category with six teachers and teacher representatives from any union in primary and secondary (including special schools) schools in Slough.

15. Antisemitism/Islamophobia - Council Motion

The Senior School Effectiveness Officer introduced a report from the Head of Democratic Services that advised the SACRE of a motion passed at Slough Borough Council meeting on 23 July 2019 seeking the support of SACRE in the Council's commitment to promote religious harmony and tolerance.

Members were requested to consider the motion and comment on any action that might be appropriate for SACRE to take to support the motion.

Members discussed various aspects of the report including the Council's commitment to promote religious harmony and tolerance, which they stressed was already enshrined in the role of SACRE and its work in supporting schools and their curriculum.

Members considered that the MEND (Muslim Engagement and Development) definition of islamophobia was inappropriate and was not universally recognised, compared to the internationally recognised definition of antisemitism by the International Holocaust Remberance Alliance (IHRA). It was also perceived that the issue of islamophobia appeared to have been included at the last possible moment without significant consideration of the issue and alternative definition from the Muslim Council of Britain.

The SACRE noted that the motion had already been unanimously agreed at the Council meeting but nevertheless acknowledged that the main focus should be on the importance of supporting religious education (RE) in schools and promoting a better understanding of the issues of antisemitism and islamophobia. These issues could be incorporated in the syllabus and promoted through good practice during lessons and by inviting speakers to give a talk at assemblies.

Members agreed that provision of training on islamophobia would be helpful in promoting a better understanding of the issue and requested the Council to provide additional funding to support the training sessions as the SACRE budget was limited.

The SACRE Adviser would provide estimated costs for provision of separate training sessions for primary and secondary RE teachers and co-ordinators in Slough Schools to be met by additional Council funding.

Members recommended that it was incumbent on the Council to further promote religious harmony and tolerance by raising awareness through events commemorated in the community as well as those celebrated nationally.

Resolved:

- i) That the Antisemitism/Islamophobia Council Motion be noted.
- ii) That it be requested that additional funding be allocated by the Council for SACRE to provide training sessions to support RE teachers and co-ordinators in primary and secondary schools in order to further promote religious harmony and tolerance within the school curriculum.
- iii) That SACRE recommended the Council to further promote religious harmony and tolerance by raising awareness through events commemorated in the community as well as those celebrated nationally.

(Julie Siddiqi and Zubayr Abbas-Bowkan left the meeting).

16. Summary of the analysis at KS4 and KS5 Religious Studies/Education for 2018/19

Members noted the summary of the analysis at KS4 (Key Stage) and KS5 Religious Studies/Education reports for 2018/19.

It was noted that there were students who had not taken RE at exam level and questioned whether any provisions had been made my schools to provide some RE teaching.

Members discussed that schools may value any support that SACRE could provide. SACRE therefore agreed that the Chair/Vice-Chair and Professional Adviser would draft a letter to headteachers and RE leads/co-ordinators offering advice and asking what material resources they may require that SACRE could support the school with in the provision for non-GCSE RE students. SACRE would provide support to any schools in Slough that requested it:

Resolved:

- i) That Summary of the analysis at KS4 and KS5 Religious Studies/Education for 2018/19 be noted.
- ii) That the Chair/Vice-Chair and Professional Adviser would draft a letter to headteachers and RE leads/co-ordinators offering advice and asking what material resources they may require that SACRE could support the school with in the provision for non-GCSE RE students.

17. SACRE Newsletter

The SACRE Adviser introduced the SACRE newsletter for RE teachers and RE leads, that would be circulated to all schools in Slough via The Link, the system used in Education Services to communicate with schools.

Members welcomed the newsletter and noted the information that would be provided to schools.

Resolved- The SACRE newsletter for RE teachers and RE leads in Slough Schools be noted.

18. SACRE Financial Update

The Senior School Effectiveness Officer gave an update on the SACRE budget for 2019/2020.

It was confirmed that from the £5,000 allocation for the 2019/20 financial year, $\pounds 2,355$ had been spent. Members were reassured that the remaining $\pounds 1,695$ could be carried over into the next financial year to cover some items that had been earmark that would continue into the new financial year.

It was noted that £1,300 had been ring fenced in 2016 for purchasing RE resources (formerly stored at Montem Primary School) but it had not been used since it could not be established where the money had been kept within the education budget codes. Members requested the Senior School Effectiveness Officer to investigate and report back the outcome a SACRE meeting.

The money would be used to purchase RE resources that would be given to schools on loan to support RE teaching. Schools would be asked about the types of resources that they needed via the SACRE Newsletter.

Resolved – That the SACRE budget update be noted.

19. SACRE Action Plan 2019- 2020

Members noted the SACRE Action Plan.

Resolved – That the SACRE Action Plan be noted.

20. Pan-Berkshire SACRE Hub Notes for Meeting held on 27 November 2019

Resolved – That the Pan-Berkshire SACRE Hub Notes of the meeting held on 27 November 2019 be noted.

1 Purpose of Report

To consider revised Terms of Reference and proposed revised membership of Committee 3 – from 'Associations Representing Teachers' to representatives of teachers and teachers representatives in primary, secondary and special schools as far as practicable.

2 <u>Recommendation(s)/Proposed Action</u>

Members are requested to consider the report and agree the proposed changes it wishes to recommend for endorsement by the Member Panel on the Constitution before being reported for approval by Council.

3. The Slough Joint Wellbeing Strategy, the JSNA and the Five Year Plan

Good governance arrangements will have positive implications for the SJWS and the JSNA.

4 <u>Other Implications</u>

(a) <u>Financial -</u> There are no financial implications arising from this report

5 Supporting Information

- 5.1 At its meeting on 4 March 2020, Members proposed that the SACRE Terms of Reference be reviewed to amend Committee 3 category; to replace the current named unions with six teacher representatives from any union in primary and secondary (including special schools) schools in Slough.
- 5.2 There had been a long-standing issue of high level of vacancies in Committee 3 and Members were of the view that membership in this category should be considered more widely to include RE teachers at primary and secondary level. The Committee agreed that a review of this category would help strengthen engagement with school

leaders and teachers. A number of the Associations representing teachers in this category were also out of date as several of the associations had merged.

5.3 Terms of Reference

5.3.1There have been no legislative changes that have required Slough SACRE Constitution to be amended or updated. However, Circular 1/94, Religious Education and Collective Worship issued in 1994 has since been replaced by Religious Education in English Schools: Non-statutory Guidance 2010, which replaced the elements of Circular 1/94 relating to RE.

Members are requested to consider the information in Appendix 1 and consider the current SACRE membership of Committee 3 - Associations Representing Teachers with a view to replacing the current named unions with six teachers and teachers' representatives from any union in primary and secondary (including special schools) schools in Slough.

Appendix 1 – Current Slough SACRE Constitution and Committee Membership

SLOUGH STANDING ADVISORY COUNCIL ON RELIGIOUS EDUCATION (SACRE) – CONSTITUTION AND TERMS OF REFERENCE

The SACRE is established in accordance with Section 11 of the Education Reform Act 1988 (as amended by Section 255 of the Education Act 1993) by Slough Borough Council acting as Local Education Authority.

Membership

1. The Members of the SACRE shall be appointed by the Authority so that they shall represent the following groups.

Committee 1 – Christian denominations and other religions (12)

The Free Churches (1) The Black Free Churches (1) The Roman Catholic Church (1) Hinduism (1) Islam (4) Judaism (1) Sikhism (2) Baha'is (1)

Committee 2 – The Church of England (4)

Committee 3 – Associations representing teachers (6)

National Union of Teachers Professional Association of Teachers National Association of Head Teachers Secondary Heads Association National Association of Schoolmasters/Union of Women Teachers Association of Teachers and Lecturers

Committee 4 – The Authority (5)

- 2. Committee 4 shall be subject to the proportionality requirements of the Local Government and Housing Act 1989.
- 3. No Member appointed to the Cabinet shall be appointed to the SACRE.
- 4. The SACRE shall be appointed by the Council.
- 5. Members of the SACRE shall serve from the date of their appointment for a term of three years or until their successors are appointed by the Authority. They shall be eligible for reappointment after each term for a further term by consultation, if necessary with the group which they represent. This shall also apply to any co-opted members who may be appointed.
- 6. Where a nominated representative fails to attend three consecutive meetings of the SACRE and fails to give their apologies s/he, shall cease to be a member of

the SACRE and the nominating body shall be invited to nominate another representative provided that:

- (a) the Clerk to the SACRE has advised the member in writing of the provision of this clause following the second missed meeting and at least a 10 working days before the third meeting.
- (b) SACRE does not decide to disapply this rule for reasons of extenuating circumstances.

Terms of Reference

- In accordance with Section 11 of the Education Reform Act 1988 (as amended by Section 255 of the Education Act 1993) to advise the Council on such matters connected with religious worship in schools and the religious education to be given in accordance with an agreed syllabus as the authority may refer to it or as it may see fit. To advise, in particular, on methods of teaching, the choice of materials and the provision of training for teachers.
- 2. On application made by a Head Teacher of any Slough school after consultation with the governing body to consider whether it is appropriate for the requirement for Christian collective worship to apply in the case of that school, or in the case of any class or description of pupils at that school. The SACRE shall arrive at its decision and communicate it to the Head Teacher in accordance with the provisions of Section 12 of the Education Reform Act 1988.
- 3. The representative groups on the SACRE other than that representing the authority may at any time require a review of any agreed syllabus for the time being adopted by the authority.
- 4. The SACRE shall each year publish a report on its proceedings and those of its representative groups, the report to specify any matters on which the SACRE has given advice to the authority and the reasons for offering that advice.
- 5. The SACRE shall take any action assigned to it by the authority in relation to the consideration and disposal of any complaint concerning worship or religious education in compliance with Section 23 of the Education Reform Act 1988.

2nd July 5.30 – 6.30 pm – online Zoom meeting

Anne welcomed every one.

Anne checked everyone had received the films made by Jerry.

Anne reported that she had emailed True Tube today to see if they would be interested in hosting the videos in theory – they are not quite ready as Jerry is going to split the films into separate Key Stages. Awaiting reply.

Action: Anne relay True Tube answer when received.

Unsure when filming can recommence due to current coronavirus situation, hopefully in the autumn. There are still three additional films to be made: Sunni Mosque in Reading, Catholic Church, and Orthodox Synagogue. David requested that the Mosque be filmed first as he had started to make contact with them before lockdown. Suggestion was made that now may be a good time to film as mot so many people in places of worship. It may mean that teachers are not invited to attend the filming to help with numbers and social distancing.

Action: David to make contact with Mosque.

Action: Anne to make contact with Jerry.

David said that West Berkshire had received additional funding as a result of the GVT lockdown and hope to be able to spend some of it on more films. A discussion followed about finances. Anne shared a spreadsheet of Hub accounts with regards to the Project. Westhill grant was £4000. Due to lockdown, not all filming has been completed and the project is now behind schedule. Westhill are aware. Still waiting for Jerry to bill the Hub for filming to date. Conference did not happen. Some of the allocated money has not been used due to lockdown so there is more money at the moment than expected. Therefore no SACRE will be asked to contribute any more in the financial year April '20 – March '21.

Anne asked 'Do we want to get the films out before there has been a chance to make notes, guidance and lesson plans?' A discussion ensued and the result was that it would be better to release the films (once in separate key stage films) with simple notes such as key vocabulary, key question it relates to, how it fits into the SACRE Syllabus and four or five learning points. This would be ready by the beginning of the new academic year. It would be later in the term that teachers would be gathered to work on lesson plans to go with each film/key stage.

Anne said that there had been an extra question during the Jewish filming about kosher food and the group decided that it should be kept in.
