Decisions to be made by the Cabinet in private as a matter of urgency Date of Notice: 31st January 2013

Local authorities are required to publish a Notice of key decisions and/or of their intention to hold a meeting of the Executive ('the Cabinet') in private at least 28 clear days before the meeting. This Notice sets out decisions to be taken in private at the meeting of the Cabinet on 11 February 2013 which have not been included on previously published statutory notices (the Forward Plan). Reason for urgency	The Council has been involved in negotiations with Wexham Court Parish Council to secure the release of some land for redevelopment. Having secured an agreement in principle, the Council needs to consider and if satisfied agree to proceed in a timely manner to allow the agreement to be formalised.

Item	Services to Schools – Outcome of 2 nd Stage Procurement

Reason for urgency	The Cabinet agreed to commence the 2 nd stage of a procurement process for Services to Schools at its meeting on 19 th November 2012. The procurement process has progressed to the tender evaluation stage and it is not practicable to defer consideration of the report until March. A report will be considered in the public meeting however it is anticipated that exempt information will be included in a Part II Appendix .
