PUBLIC PATH EXTINGUISHMENT ORDER 2008**

This order is made by Slough Borough Council (“the Authority”) under Section 118 of the Highways Act 1980 (“the 1980 Act”) because it appears to the Authority that the footpath described in paragraph 1 below is not needed for public use.

The Council has had due regard to the needs of agriculture and forestry.

BY THIS ORDER

1. The public right of way over land situated at Wood Lane, Slough, and shown by a continuous bold line on the map attached to this order and described the Schedule to this order, shall be extinguished on the date of confirmation of this order.
2. Notwithstanding anything contained in paragraph 1 of this order, where, immediately before the date on which the highway is stopped up in pursuance of this order, there is apparatus in, under or across that highway belonging to the statutory undertakers for the purpose of carrying on their undertaking, the undertakers continue to have the same rights in respect of the apparatus which they then had.
3. This order may be cited as the Slough Borough Council Footpath 18 Slough (Part) Public Path Extinguishment Order 2008.

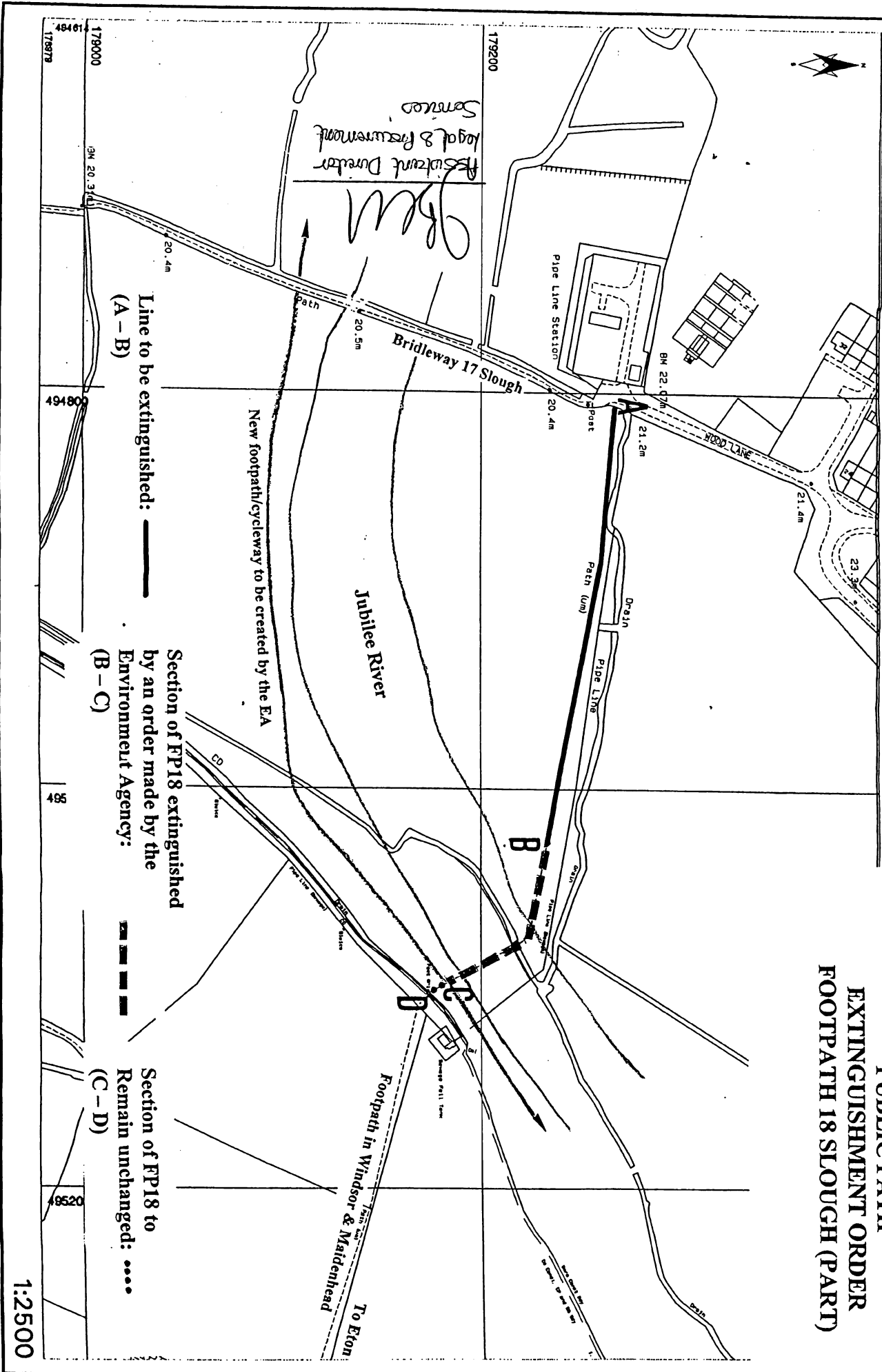
