

# SLOUGH BOROUGH COUNCIL (6 Carlisle ROAD) COMPULSORY PURCHASE ORDER 2020

## The Housing Act 1985 and the Acquisition of Land Act 1981

The **SLOUGH BOROUGH COUNCIL** (in this order called "the acquiring authority") makes the following order:-

- 1. Subject to the provisions of this order, the acquiring authority is under section 17(1)(b) of the Housing Act 1985 hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of the provision of housing accommodation.
- 2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown edged red on a map prepared in duplicate, sealed with the Common Seal of the acquiring authority and marked "Map referred to in the Slough Borough Council (6 Carlisle Road) Compulsory Purchase Order 2020."
