THE BOROUGH OF SLOUGH (PRESCRIBED SCHOOL ROUTES) - HOLY FAMILY CATHOLIC SCHOOL) (EXPERIMENTAL) ORDER 2022 (ORDER 44 OF 2022)

Sections 9 and 10 of the Road Traffic Regulation Act 1984 and regulation 22 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 as amended.

- 1. SLOUGH BOROUGH COUNCIL gives notice that on **20th October 2022** it made an Experimental Order ("the Order") under sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and any other enabling powers.
- 2. The effect of the Order is to introduce a road closure for vehicles into High Street, Langley, for the length specified in the Order, operating between 8.15 a.m. and 9.00 a.m. and between 3.00 and 3.45 p.m. on Mondays to Fridays inclusive during school term times of Holy Family Catholic School. During these times, no vehicle should enter, leave or proceed in High Street (unless exempt).
- 3. Access for residents and School staff will be maintained by the introduction of a school street permit scheme. Access to the properties in the restricted area is to be maintained for the delivery/collection of goods/services and passengers.
- 4. Statutory exemptions to emergency services and other vehicles used by the Council and utilities to be maintained.
- 5. The purpose of the road closure is to allow for the operation of a "school street" in order to provide a safer environment for children attending Holy Family Catholic School whilst arriving at, and leaving, the school.
- 6. The Order now made comes into force on **31**st **October 2022** and shall remain in force for a period not exceeding 18 months.
- 7. A copy of this notice, the Order, a plan showing the part of the highway affected and a statement of the Council's reasons for making the Order may be inspected free of charge on the Council's website at https://www.slough.gov.uk/public-notices-2/public-notices-orders/4 or at the locations listed below in normal opening hours (excluding bank holidays and public holidays):
 - Observatory House, 25 Windsor Road, Slough SL1 2EL
 - The Curve, William Street, Slough SL1 1XY 6 until **2**nd **May 2023.**
- 8. The Order provides that in pursuance of Section 10(2) of the Road Traffic Regulation Act 1984, the delegated authority of Slough Borough Council, or some person authorised in that behalf, may if it appears essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Order runs, modify or suspend the Order or any provision thereof.
- 9. In due course the Council will consider whether the provisions of this Experimental Order should be continued in force indefinitely ("Permanent Order"). Anyone wishing to object to such a Permanent Order may do so within six months of the day on which this Order came into force. Any such objection must be made in writing, stating the grounds on which it is made, and be sent to the address below.
- 10. Any person wishing to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Act, or that any requirement of the Act or of any regulations made under the Act has not been complied with may, within 6 weeks from the date on which the Order was made, apply to the High Court for this purpose.
