Equalities in Housing 2023

Introduction

Both the private rental market and the social housing sectors are feeling the effects of the current economic climate. Private sector landlords are leaving the sector due to ever increasing borrowing rates, greater exposure to tax, and regulatory changes. The private sector landlords that are staying are increasing rents, both because of the increase in borrowing rate and due to the fact that demand is outstripping supply.

As private sector accommodation is at a premium this increases the service demand for social housing, as low income families struggle to afford private rental prices.

The housing directorate continues to manage significant challenges in providing a range of core services to its tenants and leaseholders, and in the wider context in respect of accommodation services especially relating to homelessness and the management of Temporary Accommodation (TA).

The Directorate is working on services improvements to ensure the Council meets its statutory and service objectives to ensure compliance with the new Consumer Standards set out by the Regulatory of Social Housing (the Regulator), which include the Home, Tenancy, Neighbourhood and Community, Tenant Involvement and Empowerment and Tenant Satisfaction Measures standards.

One of the recent challenges for the housing directorate was the replacement of its housing management system. This has encountered some implementation issues, leaving the department with limited IT capability. There has been a phased implementation of the new NEC housing system with the allocations module being the most recent to become operational. We now expect to see a significant increase in lets being made, with approximately 60% of these lets going to those currently in Temporary Accommodation , moving those people from TA into more suitable permanent accommodation and reducing the council's TA expenditure. The completion of full implantation of the NEC system is expected in the first quarter of 2024.


Due to the phased implementation of the new NEC housing system the amount of current equalities data presented is limited but this situation will improve as more of the NEC system become operational. Some of the data presented will be from the last data runs from the previous housing system in October 2022.

Overview of equalities and housing data in Slough using the 2021 Census data

In the 2021 Census, there were 52,423 households consisting of one or more people in Slough.


Slough has the largest average household size in England and Wales, with 3 people per household, compared to 2.4 for England and Wales.

15.8% of Slough's households are overcrowded, which is much higher than the England average of 4.4%.



Age


Slough's population in the 2021 Census was 158,500. Slough has a young population, with 25% of residents aged 0 -15, 65.4% aged 16-64, and 9.7% aged 65 or over. Slough's average age is 34, compared to 41 for the South East and 40 for England. Slough has the second highest proportion of children aged 15 or under in England and Wales.

The proportion of Slough's population aged 15 and under has increased since 2011 (although the number of 0-4 year olds has decreased by 8%) while the proportions of residents aged 16 to 24 and 25 to 34 have decreased.





Proportions based on age






The data shows a trend towards disabled residents living in smaller 1-2 person households and not disabled residents living in 3-4 person households.


18% of disabled residents in Slough live in overcrowded homes compared to 27% of not disabled residents.







32% of Slough's population are Christian and 29.4% are Muslim.












Household size

90.4% of Slough's population (aged 16 and over) identify as the same gender as their sex registered at birth and 0.9% identify as a different gender to their sex registered at birth.



Stock and Tenants

Housing register

The allocation of social housing (both Council owned homes and housing association properties) is largely driven by government policy. Prior to the Localism Act 2011, social housing was allocated to those who were 'most in need' who were granted 'lifetime' tenancies. The Localism Act gave local authorities the freedom to determine their own allocations schemes and set the eligibility criteria that must be met in order for a household to be placed on the Housing Register and also introduced Flexible (fixed term) Tenancies with the aim of supporting local landlords to make the best use of their housing stock.

The following table represents the ethnicity of those on the housing register as at 03/10/22, with a percentage comparison against the previous data reported 03/01/20. There was no change to the largest ethnic groups represented: they still show as Pakistani, White British and Other White but Pakistani has increased by just under 3% while White British has reduced by 4.32%.

Lettings to those on the Housing Register

The total number Housing Register lets as with all types of housing lets in 2022-23 were down considerably due to issues with the implementation of a new Housing System. In 2021-22 there were a total of 234 Housing Register Lets compared to just 160 in 2022-23.

It is difficult to make any comparisons between the those on the Housing Register and those who have received a property let, this is due to a number of factors such as size, type, location of the property to name but a few.

The same top six ethnic codes appear in the letting table as those on the Housing Register table with only the codes White British swapping places with Pakistani. White British had 25.00% of the Housing Register lets and Pakistani very close with

24.38%.
