Slough is predominantly an urban area situated in the east of Berkshire. Slough has a population of over 158,000 and the borough is considered to be one of the most ethnically diverse in the United Kingdom, outside of London with approximately 120 different languages are spoken in Slough's schools.

Neighbouring authorities include the Royal Borough of Windsor and Maidenhead (RBWM) to the west and Surrey County Council to the south, Buckinghamshire County Council to the north and west, and the London Borough of Hillingdon to the east. Slough shares many similarities with some London boroughs. Slough is also integrated into the heart of the UK transport and communications network. located between the M4, M40 and the M25. The town is an important commercial centre and includes large industrial as well as residential areas.

The Procurement Act 2023

The Procurement Act 2023 is designed to simplify and modernise the public procurement system, making it easier for businesses to compete for and win public contracts.

The Act will come into effect in 2024, and there are a number of things that businesses need to do to prepare. Here is a brief guide:

- Understand the changes that the Act will introduce. The Act will make a number of changes to the way public procurement is conducted, including:
 - Consolidating four sets of regulations into one
 - Introducing a new procedure for running competitive tendering processes
 - Requiring contracting authorities to have regard to the needs of small businesses
 - Increasing transparency throughout the procurement process.

- 2. Start planning your procurement strategy. Once you understand the changes that the Act will introduce, you need to start planning your procurement strategy. This will involve identifying the public contracts that you are interested in bidding for, and developing a plan to win those contracts.
- 3. Get familiar with the new rules and regulations by getting familiar with the changes by reading the government's guidance on the Procurement Act.
- Build relationships with public sector buyers. One of the best ways to win public contracts is to build relationships with public sector buyers. This means getting to know them, understanding their needs, and demonstrating that you can meet those needs.

- 5. The Procurement Act is a significant piece of legislation that will have a major impact on the public procurement market. By understanding the changes that the Act will introduce and taking steps to prepare, businesses can position themselves to take advantage of the new opportunities that will be created.
