Section 1 and 2 of the Road Traffic Regulation Act 1984 and Regulation 23 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 as amended.

The Borough of Slough (prescribed routes) Order 2024 (Order 23 of 2024)

1. Slough Borough Council gives notice that on 25 April 2024 it made an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984 (“the Act”) and any other enabling powers.
2. The Order makes permanent the effects of The Borough of Slough (Prescribed School Routes – Holy Family Catholic School) (Experimental) Order 2022 (Order 44 Of 2022). The effect of the Order is to introduce a road closure for vehicles turning into High Street, Langley, Berks, SL3 8NF in order to reduce the number of vehicles around Holy Family Catholic School, operating between 08:15am and 09:00am and between 03:00pm and 03:45 p.m. on Mondays to Fridays inclusive during school term times. During these times, no vehicle should enter, leave or proceed into High Street, Langley, Berks, SL3 8NF (unless exempt).
3. The road closure will not apply to pedal cycles. Access for residents and School staff will be maintained by the introduction of a school street permit scheme. Access to the properties in the restricted area is to be maintained for the delivery/collection of goods/services and passengers. Statutory exemptions to emergency services and other vehicles used by the Council and utilities to be maintained.
4. Waivers will be issued by the Council to residents of High Street, Langley, Berks, SL3 8NF and staff working at - Holy Family Catholic School to authorise them to pass through the road closure whilst it is in operation. Emergency services vehicles will also be exempt from the closure.
5. The Order now made comes into force on 25 April 2024.

Any person wishing to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Act, or that any requirement of the Act or of any regulations made under the Act has not been complied with may, within 6 weeks from the date on which the Order was made, apply to the High Court for that purpose.
