CALL FOR SITES CONSULTATION [REG 18 TCPA 2012]

Slough Local Planning Authority [LPA] is holding a call for sites exercise to ask people to share information on sites within Slough Borough that could contribute to providing housing and other uses for our communities over the next 20 years.

The results will be used to inform work to identify areas for housing, employment, and other uses needed across Slough for the Slough Local Plan 2025-2045. The Local Plan is an important part of the planning system and has a major role in deciding planning applications and supporting regeneration.

This notice and the details below are to meet the LPAs duty under Reg. 18 and Reg. 35 of the TCPA Regs 2012, that the LPA make consultation documents available and consult residents or others carrying on business in the LPA's area, including specific bodies (such as statutory consultees), and general bodies that represent interests in the Borough.

Consultation Period

The consultation will run from **4th April 2025 to 23rd May 2025 23:59** ("Consultation Period") and the LPA requires responses to be submitted no later than the end of the Consultation Period.
