THE BOROUGH OF SLOUGH WAITING RESTRICTIONS AND PARKING PLACES (CONSOLIDATION) ORDER 2017 (AMENDMENT No. 49) ORDER 2025 (Order 51 of 2025)

Sections 1, 45, 46 and 53 of the Road Traffic Regulation Act 1984.

1. SLOUGH BOROUGH COUNCIL makes this Order in exercise of its powers under sections 1, 45, 46 and 53 of the Road Traffic Regulation Act 1984 and any other enabling powers.

2. The Order shall come into operation on the date stated in the notice of its making.

3. While the Order is in operation, the Slough Borough Council Waiting Restrictions and Parking Places (Consolidation) Order 2017 ('the 2017 Order') shall be amended as follows:

(a) The item in Schedule A to this Order is to be added to Article 4 to the 2017 Order;

(b) The items set out in Schedule B to this Order are deleted from Schedule 1.01 to the 2017 Order;

(c) The items set out in Schedule C to this Order are added to Schedule 1.01 to the 2017 Order;

(d) The items set out in Schedule D to this Order are deleted from Schedule 2.01 to the 2017 Order;

(e) The items set out in Schedule E to this Order are added to Schedule 2.01 to the 2017 Order;

(f) The Schedule set out as Schedule F to this Order is added as Schedule 4.32 to the 2017 Order.

(g) The items set out in Schedule G to this Order are added to Schedule 8.01 to the 2017 Order;

(h) The items set out in Schedule H to this Order are deleted from Schedule 8.02 to the 2017 Order; and

(i) The items set out in Schedule I to this Order are added to Schedule 8.02 to the 2017 Order.

STATEMENT OF REASONS

This Order introduces a shared use parking arrangement, incorporating both residents permit parking and limited waiting parking place in Elmhurst Road, Langley. It also establishes permit eligibility for this road and introduces waiting and loading restrictions operating at all times into a certain length of that road.

The purpose of this Order is to provide provision for resident permit holders while facilitating short term parking for visitors and customers of local businesses, thereby supporting access and turnover in the area.
